

one destined to attain mastery over all his enemies, by the force of genius and the wisdom and integrity of his mind. "His Majesty's Opposition" had absolutely fled from the field, and were to be seen in den array behind the leading members of His Majesty's Administration. On the Treasury Bench was Mr. Calcraft and Mr. Western, seated beside Mr. Wynn, Mr. Croker, and subsequently Mr. Canning, Mr. Huskisson, &c. On the second bench sat Mr. Tierney, Sir Francis Burdett, Lord Duncannon, and others. On the third Bench, Mr. Brougham had taken his place, together with Sir R. Wilson, Mr. Leicester, Mr. Fowell Buxton, Lord Nugent, and several other Members of the Opposition. On the fourth bench were to be seen, Lord Sefton, Mr. Gordon, Mr. W. Smith, and so on up to the sixth bench from the floor into the remotest corner of the House. A more full attendance, indeed, could not be conceived—nor did it seem possible to find room for one additional Member in any part of the building. The side galleries were crowded to excess. Many Peers, amongst whom were Lord Bexley, Lord Farnham, Lord Roden, the Bishops of Lichfield and Bath and Wells, were accommodated with seats in this part of the House; the Duke of Norfolk was also here, and appeared to take a deep interest in the proceedings. But that which puzzled the skill of the most experienced attendants of the House was to discover who were the Members in possession of the Opposition Benches. With the exception of Joseph Hume, Esq. who was constant to the pillar erected for the support of the side gallery, on the third bench, and Lord Milton in his usual seat, it was impossible, among the crowd of faces, to recognise any one accustomed to shine or take any part in the business of the House.

It is stated that the general move which was made to the Treasury Benches, on the first night of Mr. Canning's appearance as Prime Minister, arose from a desire to have a large shew of the landed interest in his favour, and that, in fact, there was seated on the bench behind him, a rental of upwards of £250,000 a year.

Extract of a Letter from a friend in London, dated May 31.

Lord Goderich has, I understand, made a communication to the Admiralty respecting the recent Packet arrangement, and I hope in a few days to hear the result. Mr. Vaughan has strongly complained to Government of the delay which takes place in the conveyance of his despatches, and has proposed that in future, all communications to him should be transmitted in the Packets sailing for New York. The Ministry is, I think, finally settled—the great mass of the people are warmly in favour of the New Government. Lord Wellington's resignation of his command, with reference to his long services, is generally regretted, that of Mr. Peel also; but little sympathy is evinced for the others who have seceded from the Cabinet. The country is surmounting its difficulties, and business is improving in almost every branch. His Majesty has had an attack of the gout, which continued for three days; he is, however, getting over it. The naval people are highly delighted with the change at the head of the Admiralty, and are flocking from all parts of the Kingdom, to pay their respects to their new Chief, whose popularity is every day increasing. Parliament will rise about the 20th June. The Corn question is settled—the Estimates voted, and this evening Mr. Canning brings forward the Budget; there are no other questions before Parliament which can occasion any trouble. On Thursday the Clergy of the Province were convened by the Venerable Archdeacon BATES, at Kingston.—Divine Service was celebrated at the Church of the Rev. Mr. SCOVIL, when an excellent and appropriate Charge was delivered by the Archdeacon.

The Clergy were detained only that day by the business which occasioned their meeting, and separated after having been notified by the Archdeacon that his next visitation would be held in the course of the ensuing year at Fredericton.
