

On Monday, the 10th inst. at 1 o'clock, p. m. a fine brig named the *George Canning*, of nearly 300 tons burthen, was launched from the Ship-yard of Mr. William Dickson, of Truro. The day was uncommonly serene, and never did a ship take the water in more superior style. This is the third launch from the same establishment within these two years, amounting in the whole, to upwards of 1000 tons; and it is supposed by persons of high mechanical talent, who had opportunities of inspecting the yard, that, in point of Model, Construction and Workmanship, three more perfect and substantial vessels never were sent from these Provinces—a circumstance which reflects no little degree of credit on the master-builders, who are all natives of that part of the Country.—*Halifax Journal, July 30.*
