THE KING'S COURT.

(FROM THE COURT CIRCULAR.) Yesterday afternoon at two o'clock, His Majesty held a Court at his Palace in St. James's, which was attended by His Royal Highness the Duke of Clarence, their Excellencies the Russian and Prussian Ambassadors, the late and the present Lord Chancellor, the Lord President of the Council, the late and the present Lord Privy Seal, the late and the present Secretary of State for the Home Department, the late and the present Secretary of State for the Foreign Department, the late and the present Secretary of State for the Colonial Department, the President of the Board of Control, the President of the Board of Trade, the Chancellor of the Duchy of Lancaster, the Master-General of the Ordnance, the Secretary of War, the Secretary of State for Ireland, the Vice-Chancellor, the Attorney General, the Lord Chamberlain, the Lord Steward of the Household, the Groom of the Stole, the Master of the Ceremonies, the Clerk Marshal as the Equerry in Waiting, Lord Graves in Waiting, General King, Groom in Waiting, Admiral Sir George Cockburn, &c.

The Lord Chancellor (Earl of Eldon) had an audience of His Majesty, and resigned the Great Seal. Earl Bathurst had an audience of His Majesty, and resigned the Seals of Office as Secretary of State for the Colonial Department. The Earl of Westmoreland had an audience of His Majesty, and resigned the Privy Seal. Mr. Peel had an audience of His Majesty, and resigned the Seals of Office as Secretary of State for the Home Department. Mr. Canning had an audience of His Majesty and delivered his Seals of Office as Secretary of State for Foreign Affairs. Lord Lyndhurst was presented to His Majesty on his being appointed Lord Chancellor, when His Lordship kissed hands, and received the Great Seal. The Right Hon. George Canning was presented upon his being appointed First Lord of the Treasury and Chancellor of the Exchequer, and received the Seals of Office accordingly. His Grace the Duke of Portland was presented, upon his being appointed Lord Privy Seal. The Right Hon. Sturges Bourne was presented upon his being appointed Secretary of State for the Home Department, and received the Seals of Office. Lord Dudley and Ward was presented, upon his being appointed Secretary of State for Foreign Affairs, and received the Seal of Office. Lord Godrich was presented, upon his being appointed Secretary of State for Colonial Affairs, and received the Seals of Office. The following Presentations also took place: The Marquess of Anglesea, upon his being appointed Master General of the Ordnance.

The Duke of Devonshire, upon his being appointed Lord Chamberlain. Mr. William Lamb, upon his being appointed Secretary of State for Ireland. Mr. James Scarlett, upon his being appointed Attorney-General, upon which occasion he received the honour of Knighthood. Mr. Hart, upon his being appointed Vice-Chancellor, upon which occasion he received the honour of Knighthood. His Majesty then held a Privy Council, at which Mr. Poulter attended as Clerk, when his Grace the Duke of Portland, the Duke of Devonshire, the Marquess of Anglesea, Lord Dudley and Wards, Admiral Sir George Cockburn, Sir Anthony Hart, and the Hon. Wm. Lamb, were sworn in Privy Counsellors.

The following were sworn into office: The Lord Chancellor (Lyndhurst,) the Right Hon. Sturges Bourne, Lord Dudley and Ward, the Marquess of Anglesea, who was also sworn in Lord Lieutenant of the Tower Hamlets.

The Court concluded at a quarter after four o'clock. When Mr. Canning alighted from his carriage in the Entre Yard, he was loudly cheered by a numerous assemblage of persons who were collected there. Mr. Secretary Peel arrived a few minutes afterwards, he was also loudly greeted; and as Mr. Canning left the Palace, he was again loudly cheered.

G R E E C E.

The Dutch papers encourage a rather favourable view of the present prospects of the Greeks, and give, on the authority of Dr. Gosse, of Geneva, a statement of the Greek force by sea and land, which, it is added, was as accurate as could be obtained, by which the Military are reckoned at 28,000, and their Marine at 121 polacres, brig and fire ships.

Trieste, April 12.—During the celebration at Nauplia of the late victories obtained over the Turks, salutes of artillery from the fortress of Palamide announced the arrival of Lord Cochrane. This brave mariner entered the port of Nauplia on the 17th of March. Scarcely was the name of this new Messiah for Greece heard, when all the population hastened to the port. In a few minutes the whole shore was lined with men of all ages and classes, and the women impatient to see the long expected hero, soon filled the ramparts of the fort.—Lord Cochrane no sooner stepped ashore, than the cries of joy burst forth on every side. No just idea can be given of the scene. We are assured that Lord Cochrane and all his suite were much affected by the enthusiasm of the Greeks. He entered Nauplia, amidst reiterated cries of "Cochrane and liberty." The women on the walls scattered garlands of flowers on him. The Government Commission has rendered all possible honour to the hero who comes to embrace the cause of Greece. This new defender of Grecian liberty has had some conferences with the Greek leaders, and he has determined to sail in three days, with fifteen ships under his command. We know not whether he intends to direct his course; but he has found every thing he had required ready. The Greeks who had conversed with him are full of enthusiasm. They recognise him a man who does not lose his time, but who is eager for action. Accounts from Zante state, that this news having reached that island, three regiments of volunteers were formed there, and their chiefs are only waiting for a favourable opportunity to ship them for the Peloponnesus. We trust that this year will prove a fortunate one for Greek independence. Every thing is favourable, and the spring commences under promising auspices for Greece.

Mr. Galt, standing on the trunk, proclaimed, "God bless our beloved King, and prosperity to the city of Guelph"—after which, refreshments with libations of wine, were partaken of by the multitude, while the air rang with "God save the King."

This, we believe, is the first city so named in honour of the Royal family.
