

to improve the road from Charles Loyd's to Amos Hartley's in the Parish of Wakefield.

The sum of twenty pounds to improve the road from the River Saint John to Coldstream or New Settlement in the Parish of Wakefield.

The sum of twenty-five pounds to finish the bridge over the Blind Thoroughfare and improve the road from the County line to Samuel Upton's.

The sum of twenty pounds to improve the road from Burpee's Mill to Thomas Gowan's through the Greenfield settlement.

The sum of twenty pounds to improve the road through the new settlement in the parish of Barton commencing at the lower line of Kimbell's farm and ending at Burpee's Mill.

The sum of thirty-five pounds from Mrs. Smith's to Sealey's and to pay for a certain bridge that hath been built.

The sum of ten pounds to improve the road from the Saint Andrews road to the landing at the French Lake.

The sum forty five pounds to improve the road from Partlow's landing to Stephen Kency's.

The sum of forty pounds to improve the road from Ezekiel Sealey's to Lawrence Massereau's.

The sum of seventy pounds to improve the road and pay for bridges that have been built between Hart's Mill and Solomon Tracy's.

The sum of eighty pounds in addition to the sum of twenty pounds for the road from Cardigan to the upper settlement on the south west branch of the Miramichi River.

The sum of one hundred pounds to complete the bridge over the Mill Cove below Moorfields.

The sum of thirty pounds to enable the Inhabitants of the Butternut Ridge to open a road from that settlement to Studholm's Mill Stream.

To His Excellency the Lieutenant-Governor, or Commander-in Chief for the time being, the sum four hundred pounds, for the purpose of enabling a Supervisor of the great road from the City of Saint John to the Province line, to widen the said road leading through the marsh near the said City.

To the Commissioners to be appointed by His Excellency the Lieutenant-Governor, the sum of one hundred pounds for improving the new Shepody Road so called, laid out for settling Emigrants from the head of Hammond River to Hopewell.

II. And be it further enacted, That the said several and respective sums of money and every part thereof, shall be paid to the several and respective persons who shall actually work and labour in making, completing and repairing the said several roads and bridges, or in furnishing materials therefor, at the most reasonable rates that such labour and materials can be provided, and the several and respective persons who shall be entrusted with the expenditure of the said several and respective sums shall keep an exact account for the expenditure thereof, and shall produce receipts in writing from the several and respective persons to whom any part of the said money shall be paid, as Vouchers for such payments; and render an account thereof upon oath (which oath any Justice of the Peace in the several and respective Counties is hereby authorized to administer) to be transmitted to the office of the Secretary of the Province for the inspection and examination of the General Assembly at their next Session; and such Commissioners, or persons entrusted with the expenditure of the several and respective sums of money shall stand charged and chargeable with all sums of money entrusted to them, and not accounted for as aforesaid, and shall repay the same into the Province Treasury.

III. And be it further enacted, That the

said Commissioners or persons entrusted with the expenditure of the said several and respective sums of money shall for their time and trouble be allowed to retain at and after the rate of five per centum out of the said sums so entrusted to them respectively, together with a reasonable compensation for actual work and labour performed by them on the said several roads and bridges.

IV. And be it further enacted, That all the before mentioned several and respective sums of money shall be paid by the Treasurer by Warrant of His Excellency the Lieutenant-Governor, or Commander-in Chief for the time being, by and with the advice and consent of His Majesty's Council out of the monies now in the Treasury, or as payments may be made at the same, and not otherwise.

Circular to the Magistrates of the County of York.

SECRETARY'S OFFICE, Fredericton, 9th March, 1827.

SATISFACTORY assurances having been conveyed to His Majesty's Government of the earnest wish of the Government of the United States to reciprocate the conciliatory disposition shown in regard to the Disputed Territory, at the upper part of the River Saint John, it is most desirable, until the question relating thereto shall be finally settled, that no new settlements shall be made, or any timber or other trees felled, in the wilderness part of that Territory, nor any act done which may change the state of the question as it existed when the Treaty of Ghent was executed.

I am therefore commanded by His Excellency the Lieutenant-Governor to desire that you will be vigilant and use your utmost diligence to discover any attempts which may be made by any of His Majesty's subjects to intrude upon any part of that Territory with a view to make settlements or to procure timber, and to make immediate representation thereof to His Majesty's Attorney General, that legal steps may be taken to punish such Intruders and Trespassers; and should you discover similar attempts to be made by any other persons whether unauthorized or appearing to act under colour of authority, that you will use your best endeavours to ascertain the names of such persons and report the same to me, with affidavits to establish the facts, for His Excellency's consideration.

ERRATA.

In one of the Acts published in our last Gazette intitled "An Act to appropriate a part of the Public Revenue for the services therein mentioned," instead of "To Thomas Morris the sum of twenty five pounds as a premium for erecting a flour and hulling Mill at Lake George in the County of York," read, To James Morris &c.

London dates to the 14th Feb. and ditto, via New York, to the 21st.

The most important intelligence is that developed in the following article, which will be read with deep regret by all classes of His Majesty's subjects, particularly as the Earl of Liverpool's illness appears to have been of a nature to preclude every hope of his recovery: but the protracted indisposition of Mr. Canning must also be regarded, at the present period, as a very serious matter.

Important from England.—The ship Octavia has arrived at Boston from Liverpool, having sailed on the 21st of February. We have not received any papers; but letters of the 21st state that Lord Liverpool had a severe attack of palsy and apoplexy on the 18th, from which he was not expected to recover. Mr. Canning still continued ill; and the indisposition of these distinguished individuals had created a great panic in the stock market, and caused a reduction of 10 per cent. in the Funds. One of the letters, "you know the great corn question was to be brought forward on the 26th: what will be done now, we cannot say; but the subject will most probably be further postponed until some change takes place in the situation of Lord Liverpool and Mr. Canning."—Am. Paper, April 3.

The West Indians appear to look upon the conduct of the United States, as touching the Colonial Trade, with the utmost indifference. They treat it as a matter altogether unworthy of the Americans, but hail it for themselves as an event of the greatest importance, because it has again induced them to consider more minutely their own fruitful resources, which they find, with some assistance from Great Britain and her North American Colonies, to be perfectly adequate to all their wants. They ridicule the idea that the Americans should fancy the West Indies cannot do without them, and seem to think that "Jonathan" has, in this instance, most woefully deceived himself. "Our forests," they say, "abound with the finest hardwood in the world, and most of the houses in the interior are built and covered from our lumber. We can also have in any quantity the Wal-laba shingles of Demetera for nearly the same price with the American express, and with these advantages, that they are procured with labour of our own subjects, and that they will last three times as long. We can also raise our own corn, which is universally allowed to be far superior to the American, and a peep at our negro market will convince the most sceptical that no country in the world can or does produce more abundant or more delicious vegetables. Our own North American Colonies can supply us most abundantly with fish and lumber. What do we therefore require from the United States? White oak staves, heading and flour. The former we can obtain from the Baltic, and as Jonathan raises more flour than he can consume, he must sell it, and in all probability a large portion of it will find its way to London and Liverpool, from whence we can have it here at as low a rate as we now obtain it direct from the United States, and this will give us the carrying trade instead of Jonathan.

The Steam Boat St. George arrived at Fredericton for the first time this Season last evening about 1/2 past 10 o'clock.—Passengers, Lord Valencia, Col. Cockburn, Capt. Estridge, (81st Regiment) and Doctor Hackett.

THOMAS DALY, a Mason who had been employed at the New College, was convicted yesterday before HENRY SMITH and GEORGE MINCHIN Esquires, sitting Magistrates, in the penalty of twen-

ty pounds, for aiding and assisting two Privates of the 81st Regt. (JOHN DONOVAN and WILLIAM GOSNELL) to desert; and for default of payment was committed to the County Gaol for two months. One of the Deserters, DONOVAN, had been previously apprehended: the other, WILLIAM GOSNELL, is a native of Cork, about 20 years of age, 5 feet 6 1/2 inches high, of a fair complexion with sandy whiskers, and was dressed in a blue coat and white corded trowsers.—He is supposed to have taken the St. Andrews road.
