

ings relative to it. The subject is therefore at an end for this year. On this question, at least, the Ministers are evidently in a minority in the House of Peers.

In the House of Lords this day, Lord Dudley, in answer to an inquiry of Lord Teynham respecting the evacuation of Spain by the French troops, remarked, that he must refuse to give any specific information; but could assure the noble Lord and the House, that the subject had not been left out of the view of the Government; and that any information that might now be afforded would do any thing but contribute to promote the object of the noble Lord.

Lord Teynham, in reply, remarked, that the occupation of Cadiz, and other ports, by French troops, if not an act of hostility against England, was at least an act of hostile feeling, and that the deepest responsibility rests with the noble Viscount and all His Majesty's Ministers with regard thereto. [Hear.]

Lord Dudley—"When the day of explanation comes, I have no doubt that it will appear that His Majesty's Government have not been unwindful of their duty. [Hear.]

The Sun of the evening of the 14th thus remarks on the abandonment of the Corn Bill: "It is with unfeigned regret that we have to announce the abandonment of the Corn Bill last night in the House of Lords.

It has always appeared to us a masterpiece of legislation, and as such we have warmly supported it. We are now exposed to all the ruinous consequences of fluctuation which it had in view to remove, and we can only trust that Providence will avert those evils which the glaring selfishness of an inveterate faction would bring upon the nation. That that party do not take the trouble of cloaking their views will be seen from the following extract from Lord Grey's speech: "If there was to be a contest," said his Lordship, "between that house and a great portion of the population, his part was taken. He was one of an order with which he must stand or fall, and to the last hour of his life, he would maintain the privileges and independence of Parliament." And yet this is the individual who was once considered the 'friend of the people,' now coalescing with Ultra Tories, from whom, according to his own words, he differs 'as far as the poles are asunder.'

The Sun after having charged Earl Grey, the "great champion of whigism," and friend of the people, with coalescing with the Ultra Tories to defeat a salutary measure, says, "With regard to the Duke of Wellington's share in the matter, we can only say, that we have too much remaining respect for the Hero of Waterloo, to trust ourselves with making any comments on such unjustifiable conduct, whilst under the influence of the serious mortification which we feel at the failure of this Bill."

**EARTHQUAKE IN THE EAST-INDIES.**

On the 29th of October the valley of Nepal was convulsed by a violent earthquake. The first shock is described as tremendous, and it caused every house to shake for some seconds after it had passed away. It destroyed six houses in the city of Catmanhoo, burying under them seven human beings. It rased to the very ground a temple near the city. It destroyed fourteen houses in the city of Paun, but happily no lives. Of the buildings of the Residency there is hardly one wall left without a crack in it, and most of the higher and ornamental parts of the Resident's own mansion are either broken off, or so injured as to require to be taken down. The sound seemed like ten thousand horse artillery thundering over a draw-bridge, at full speed, or like a deluge of water, sweeping

down a mountain torrent's channel, and carrying with it huge masses of rock. There was a continuous roar, over which more sudden and violent noises, at intervals, prevailed, and it came forward with the speed of light.

This terrific sound seemed to the writer to approach him from the South. In an instant or two it swept past the city of Catmanhoo, and the Residency, which is a mile to the North of the City. The shock followed—30,000 human voices from the city rose in one peal, the voice of the earthquake passed on to the North, and there it was answered by the echoes of a thousand mountains. The whole city of Catmanhoo was celebrating the Dewali with the customary gaming; hardly a soul was in bed; the laugh and the jeer were broken by the threat of nature's dissolution; and in one instant every voice in that thickly peopled town was raised in deprecatory despair.—*Southampton Herald.*
