That melancholy event which previous intelligence had prepared us to expect, has at length been verified: His Royal Highness the DUKE OF YORK expired on the 5th of January.

In another part of our paper we have inserted some of the most material particulars connected with the Royal Duke's last moments; and, we doubt not, they will be perused with deep, tho' painful, interest.

Those extracts which relate to His Majesty's interviews with his Royal Brother, are truly affecting, and suggest a distressing picture of the state of the King's mind on this occasion. Although conscious of his approaching end, His Royal Highness continued to exert himself, even beyond his strength, in the duties of his official station; maintaining a serenity of mind which acute suffering only had power to interrupt, and death to subdue.

The dates which have put us in possession of the above, are, London to the 13th January, and New-York and Boston to the 1st and 2nd inst., from which, in addition, we have extracted as much as our limits would allow.

The information respecting the Invasion of Portugal is very unsatisfactory; and if the French papers are correct, it has also assumed a different aspect to what we have been anticipating: but Mr. Canning, in his celebrated Speech, warns us to be extremely cautious in giving credit to the productions of the Press of France.

The N. Y. Albion of the 17th ult. has the following:— All the accounts from Portugal confirm the previous statements of the defeat of the rebels under the Marquis of Chaves.

this redoubtable hero has been proclaimed Queen and honoured accordingly!"

The Marquis de Chaves is reported to have been taken by the Spaniards and shot; and DePeyronnet and Dumas are said to have resigned their places in Paris.

NEW-YORK, Feb. 28.

DEATH OF THE DUKE OF YORK. The Duke of York died in London on the 5th of January at 20 minutes past 9 in the evening, in the 64th year of his age, of the dropsical complaint with which he had been a long time afflicted. His last words were "Now I know that I am dying." By his death the Duke of Clarence becomes heir presumptive to the throne; and in the event of his decease the daughter of the late Duke of Kent, aged 8 years, will stand in that relation to the crown.

It was rumoured in London on the 13th, that a small naval armament was about to proceed to the West-Indies, consisting of five sail of the line, one 50 gun ship, and two frigates. The direction they say has been entrusted to Sir T. Hardy, and it will be composed of a detachment from the ships in the Tagus. The object of course has not

been made public, but in private circles it is well known that should a war of principle arise in Europe, the blockade of the Havana will be a primary object with government. It is therefore not improbable, that anticipating the worst, this expedition is directed solely towards the separation of Cuba from the mother country; but whether that island is destined to become a colony of the United Kingdom, or an independent state, must depend on circumstances. In the mean time we are given to understand, that no British soldier will be sent to Cuba, unless at the request of the people.

The Amarante have always had great influence in this country; they were the enemies of the odious Marquis de Pombal, whose descendance, worthy of their father, are at present serving in the ranks, under the banner of the King. The hatred against the royalists is at its height; the peasants are troop into the city. On the 5th, a movement of the Royalists was arranged by the principal inhabitants, and a regency was formed. The selection was made by the Marquis de Chaves, and they are worthy of the grandeur of the revolution that has been effected. You may see their names in the proclamation, and you know the influence of their families enough to judge what this movement shall be.

PARIS, JAN. 9.

The whole of the news that we receive from the interior, and from the frontiers of Spain, announce, that orders have been dispatched to every province in the kingdom direct towards the frontiers of Portugal the disposable troops. In the end of December, the Spanish army of observation amounted to 24,000 men.

At Madrid, and throughout the Kingdom there exists a general clamour against the English. Such has been the efficacy of the speech and of the ultimatum of Mr. Canning, reconciling all differences of opinion, and exalting to its highest pitch the pride of the nation. At this moment Spain has no apostolics, nor Negros nor Freemasons; nothing is known amidst her population, but enemies to the English policy.

From the Constitutionnel of Wednesday.

PARIS, JAN. 9.

It is announced that Sir W. A. Court is about to be named Ambassador at St. Petersburg, and that Mr. Lamb, it is said, is named of the Spanish Government, as a preliminary satisfaction, the dismissal of the Ministers, as well as of the whole of the authorities, civil and military, who assisted in bringing the Portuguese rebels and that these functionaries should be prosecuted before the tribunals, conformably to the laws. One hundred thousand muskets, it is said, have been bought in France, for Spain, at the rate of 15 francs a piece, and that they are to be sent by Bayonne. It is not known who is to pay the million and half of francs. The convents cannot raise the sum, M. de Villellie will, without doubt, place it as he has done all the other expenses of the Spanish war, to the debit of the budget.

We have this day received a letter from Toulouse, in which our correspondent says, that he had that day, December 29, read in the Journal of the Upper Garonne, that Ferdinand, in consequence of an intercession conducted by the monks, had abdicated in favour of Don Carlos. Our correspondent adds, that this fact had been inserted in a small number only of the copies of the Journal. The news is still among the number of those that require confirmation.
