In the Upper-Canada Colonial Advocate of the 22d ultimo, an article is published on the Agricultural and Emigrant Societies, and new College, of this Province.—The writer says—"We have reason to believe that the most prosperous little spot in these Colonies, in the Province of New-Brunswick:—happy in an intelligent and united Legislature—and blessed with a Lieutenant Governor who actively and generously exerts himself, with a very laudable and disinterested purpose of heart, to better the condition of all classes of His Majesty's Subjects, as well as to provide the means for bestowing a liberal education on the youth of the Province on terms at which the poorest will not complain.

"Last week we had the New-Brunswick Courier of Sept. 30th with a full and pleasing account of the ceremonial at laying the foundation stone of the new College at Fredericton;—this evening we are agreeably employed in reading in the same journal of October 7th, an official and able account of the proceedings of the Emigrant and Agricultural Societies of St. John."—Then follow extracts from those proceedings, the whole of which are commented upon in the most encouraging terms. The writer then adds—"The accumulation of members of high respectability in the New-Brunswick Agricultural Society, noted in the report is creditable to the taste and enterprise of the colony, as well as the eminent man who presides in its Councils. In Nova-Scotia too agriculture flourishes, aided by a generous government and the skill of Mr. Young."

Our Farmers would, perhaps, do well to bear these commendations in remembrance, to deserve a continuance of them, and to turn the whole force of their exertions to the advancement of the Agricultural interests of a Colony, which holds out to them nothing but certain prospects of enriching themselves, while they are industriously engaged in labours of the most praiseworthy nature. They have the means—and have them in abundance—nothing else remains, then, but to use them.

The following extracts are from a communication addressed by, as it appears, an inhabitant of this Province; to the Editor of the Eastport Sentinel, on the 24th ult.:

"St. John, N. B. Feb. 20, 1827, Mr. Folsom,

Dear Sir,—Our Legislature is now in Session at Fredericton, and a vote has passed the House of Assembly which forbids the admission of any spectator unless he be provided with a Ticket, which is only given to a few favorites. By this arbitrary and aristocratic regulation many worthy people are prevented from seeing the inside of the Hall of Legislation."

"I have requested our Editors here to notice this outrageous and aristocratical rule just established, but their reply is, "hands off, it won't do."

We think it highly creditable to the Editors in Saint John that they did refuse such a communication:—but we would ask the writer of that letter, if he saw the "vote" he alludes to, and which he says "passed the House of Assembly," recorded in the Journals of that House?—He could not, for it is not there, neither was such a thing even dreamed of in the 'Hall of Legislation,' or in any other 'Hall,' except the 'Hall' of his own Calvaria.

From the Georgia Journal. GEORGIA AND THE UNITED STATES.

If Mr. Adams supposes he can intimidate the authorities of this state, by threatening them with the military force of the Union, he is very much in error, and he will see distinctly by the following letter, and orders of Gov. Troup, Georgia does not value a straw either Mr. Adams or his handful of regular troops, when they undertake schemes unauthorised by law, or the constitution, as in the present instance. And we should like to see him attempt to make a levy of the militia of any of the adjoining States, for a similar purpose. Let him try that if he chooses. He will find that Mr. Haile knows something of the present state of feelings on this subject in the States concerned.

Letter from the Governor of Georgia to the Secretary of War of the United States. EXECUTIVE DEPARTMENT, GEORGIA. Milledgeville, 17th Feb. 1827.

SIR—I received this afternoon from Lieut. Vinton, your letter of the 29th ult. and read within the same hour both it and the copy of it as published in the National Intelligencer of the 7th inst. No room was left to mistake the meaning of his dispatch. Lieut. Vinton announced himself, in an introductory note, a copy of which is herewith transmitted, as the Aid of the Commanding General; and you are sufficiently explicit as to the means by which you propose to carry your resolution into effect.—Thus the military character of the menace is established, and I am only at liberty to give to it the defiance which it merits. You will distinctly understand, therefore, that I feel it my duty to resist to the utmost any military attack which the Government of the United States shall think proper to make on the territory, the people, or the sovereignty of Georgia, and all the measures necessary to the performance of this duty, according to our limited means are in progress. From the first decisive act of hostility, you will be considered and treated as a public enemy, and with the less repugnance because you, to whom we might constitutionally have appealed for our defence
