We notice a paragraph in the "Upper Canada-Herald" of 24th July, expressing surprise that the amount of money collected at Kingston for relief of the sufferers by the Great Fire in this Province, is not noticed in the Report of the Commissioners. In reply to which we beg to assure our Kingston-friends, that on making inquiry at the Office, in which the voluminous documents relating to that afflicting event are lodged, we find that no account of money subscribed at Kingston was ever received here, and we imagine it must be included in the amount from York.

This Explanation we hope will be satisfactory to the subscribers at Kingston, to whom we return our warmest thanks for their liberality.

We have been favor'd with a letter from Col. Fraser, of Lake Timesquata, respecting the discovery of a Limestone quarry in that quarter, which we noticed in our number of the 31st ult. In one part of his letter, Col. F. says—"We have constructed a small Kiln, and have succeeded. The lime is rather of a yellow cast, but strong, owing, as I imagine, in having used the stones as they happened to be at hand." As we have not yet received the specimen Col. F. remarks upon as accompanying his letter, we can only add, for the present, that in conclusion the Colonel observes—"This quarry is at the foot of the Beaver Mountains, and I have reason to believe inexhaustible."

We have been informed that a house occupied by Mr. Isaac Brown, at Salmon River, was burnt to the ground, on the night of the 18th instant. The Fire broke out at midnight, and was first discovered by the fishermen on the Grand Lake, in consequence of which, many lives were saved, together with the furniture, although we lament to add that a man by the name of Peter Dewitt, perished in the flames.

CORONER'S INQUESTS.

A Coroner's Inquest was held in Sheffield on the 20th ult., before Solomon Peckley, Esq., on view of the bodies of PHILIP DOHERTY, and JOHN GALLIHAR. Verdict—"accidental death by Drowning." It appeared in evidence that those men with the wife and two small children of the latter, were crossing a small creek about fifty or sixty feet wide, in a small canoe which upset; but the woman and children were providentially saved.

And at Maugerville, before the same, on view of the body of ALLEN TAPLEY. Verdict—"accidental death by Drowning."

On the twenty-second instant, before the same, on view of the body of JOSEPH SQUIRES. Verdict—"accidental death by Drowning." The humane manner in which the body was interred, although a Stranger in that Neighbourhood, is well worthy of imitation.
