SELECTED EXTRACTS.

LONDON, Sept. 12.

ABUNDANCE OF THE ENGLISH HARVEST.—The corn harvest is, we believe, ere now, brought to a conclusion, in all parts of England; and we have the satisfaction to state, as a proof of the abundance of the crops, that we find both from our provincial correspondence, and the conversations we have had in the course of the last two or three days, with farmers, and other country gentlemen, that the number of corn stacks...most of which the thatcher has already clad in the winter garb...are much greater than have been witnessed at the conclusion of any preceding harvest of the last six years.

THE HARVEST IN SCOTLAND.—In Scotland the harvest, though (as will be seen by our Scotch agricultural report,) it did not become general in the earliest districts of that country till about the 20th ultimo, is unusually forward; and though the wheat is not, in some parts, considered so great as that of last year, which was, generally speaking abundant, the crops of corn are described as being satisfactory; those of potatoes as promising to be exceedingly good. In Ireland, the harvest, which has proved abundant, and been well got up, is nearly or quite finished.

SEPTEMBER 17.

A letter received this morning from a Banker at Paris says,—"At length it is decided that the French troops will evacuate Spain."

Should this statement be confirmed, of which, however, we have some doubt, notwithstanding the respectability of the source through which it is said to come, the situation of Spain will become one of great interest to Europe. The Apostolics will, we fear, re-establish their influence, and the destruction of all that is good and virtuous of the population will probably be resolved upon by an infatuated and bigoted faction. The evacuation of Spain by the French troops is an act of justice; but, in the peculiar condition of the country, it may nevertheless prove an occurrence by no means favourable to the interests of humanity.

SEPTEMBER 20.

GREECE.—It appears by the Paris papers which have arrived since our last, that the formal diplomatic communication to the Ottoman Government, of the treaty concluded between England, France, and Russia, on the 6th July, was made by the respective ambassadors of those Powers, on the 16th ult. accompanied with confidential notes, explanatory of the ultimate intentions of the contracting parties. It is said, that only fifteen days were allowed for the Sultan to determine what course he would pursue; in which case his decision must have been declared on or before the 31st Aug.

The Paris papers state that the Turkish troops have re-occupied Moldavia and Wallachia, in consequence of the decisive language held by the Russian Minister in favor of the Greeks. This is, of course, a violation of the treaty of Ackermann, and may

lead to a declaration of war by the Russian Government.

"City Two o'clock"—The English Funds have been very steady all the morning. Consols for Account 87 1/2. In Exchequer Bills and India Bonds there is no alteration.

"Mexican Stock 49 1/2 to 50. Colombian 29; other foreign Stocks remain at the nominal prices of last night.

"Quarter past Two.... Consols are 87 1/2. It is reported in the City that an express has arrived, with the intelligence that the English Ambassador, Mr. Lamb, has left Madrid.

Extract of a letter from the Agent to Lloyd's, dated Gibraltar, 27th August:—"On the 24th instant, between twelve and two o'clock in the afternoon, the vessel Lord Rawdon, belonging to this place, whilst coming to an anchor from a voyage in the Mediterranean, a Spanish Mistico fired and bore down on her; upon perceiving which, the Lord Rawdon, although within gun-shot of the garrison, being then close in with the ships in the anchorage, tacked and stood in a south-west course, to get nearer the walls for better protection, but was followed and fired at by the Mistico and two others which were in company. A shot having broken the Lord Rawdon's main yard, the mainsail was rendered useless, when she was boarded by two of her pursuers, with her British colours flying, opposite the King's Bastion; and as soon as they secured their prize, stood across the Bay, and had made considerable progress when the batteries opened on them. After they had all got clear of the fire, they sailed for the westward, supposed for Cadiz."—The Lord Rawdon was carried into Cadiz on the 25th ult.

Destructive Fire.—The Austrian Observer of the 11th of August contains an account of a dreadful fire which had reduced Jassy, the capital, to ruins. Nearly eight hundred houses, including the palace of the Hospodar, with all the records, &c. the palaces of the Brjands, Boznowan, &c. almost all the ware-houses, fifteen churches, convents, &c. have fallen a prey to the flames; fifty dead bodies had been dug out of the ruins, and more than 10,000 persons were left without a shelter. Dreadful was the scene at night, when buildings for an extent of two miles were in flames and thousands in the streets frantic at the loss of property and lives; a violent storm was raging at the same time the fire commenced.

We are informed by a gentleman just returned from Paris, that, since the application of Mr. Huskisson's principles of free trade to the silk manufacture, the improvement in our fabrics has been so considerable that the tables are now completely turned, and instead of French silks being smuggled into England, English silks in quantities are now smuggled into France. Free smuggling!—Lon. Pap.
