We submit the following remarks from the Courier on the above subject.

"We understand that a very considerable loss on the import value of these animals will be suffered... This was expected. But as it is altogether a Provincial concern, the loss can be viewed only as a bounty to the Agricultural interest, and we question whether a bounty granted in any other shape could have answered so good a purpose. Whatever they may have cost originally, the prices at which they have sold is an evident proof, (at least in this part of the world,) that there are individuals among us alive to our Agricultural and Farming interests, and who are able and willing to embark some capital with a view to their ultimate improvement.

On this subject we warmly entertain the hope that our Legislature will be disposed to stamp a higher value on the productions of our Rural economy than they have heretofore done, and that some considerable pains will be taken, at least by our County Members who are more immediately concerned, to point out at the next Session of Assembly, such defects as may at present exist in the recent application of Legislative or other public grants, as experience and observation may have pointed out to them... and also suggest such improvements in the system as may appear to promote the success of such a valuable branch of our Provincial Industry."

It affords us great pleasure to lay before our readers (in another column) and to recommend to their attention, a truly interesting editorial article from the Halifax Novus, of the 17th instant, upon the subject of the Mines of the Sister Province. The able Editor, it will be seen, cherishes very flattering anticipations of the future state of Nova Scotia; and our readers, while perusing the article alluded to, will quickly perceive that those anticipations are seemingly built upon a very permanent foundation. Our sincere and cordial wish is, that the parties who are engaged in such important undertakings may meet with every encouragement to go forward, and that the enterprising inhabitants of our Sister Province may long enjoy the advantages now presented to their view.
