Two or three minutes more, and the thunder cloud appeared to break on our very housetops. intervals, between the flashes of the lightening, were hardly perceptible. As far as the eye could reach the whole air seemed almost one uninterrupted mass of living flame, reddening and glowing and encreasing in vividity at every succeeding flash, as it all nature were "struggling in the jaws of death." The effects of the tornado were severely felt. Barns and other houses were upset; some carried entirely from their former sites to the distance of several perches-some unroofed, some wheeled round. We have seen some strong frame barns, so totally torn to shivers, that there is not a single stick standing. One brick house which was building in this town, but not roofed, was carried off to the foundation. One strong stone house, in the vicinity, was partly uncovered, and part of the South West gable was taken away. The roads, on the third and fourth lines of Drummond, are so choaked up with fallen trees as to render them impassable. These concessions seem to have suffered most from this direful commotion of nature.

Many cattle were killed by the falling of trees, some were so surrounded and cooped in by huge piles' on every side, that their escape appears marvellous. Whole tracts of wood land were levelled.

Altogether, in the loss of cattle, injury done to their houses, and the ravages committed on their most heavy timbered land, some poor farmers will feel it severely.

We liave not yet been able to ascertain fully the extent of the damages. The tornado did not continue longer than five minutes.

No later intelligence of any importance has been received since our last.

No definitive intelligence, that we are aware of has yet arrived here regarding the affairs of Portugal. It appears that on the attempt of Don Miguel to usurp the Crown of Portugal, several of the most distinguished and powerful of the Nobility emigrated from that Country; a step which it seems they have now so far regretted as to be about to embark for Oporto forthwith: It is said they were to sail in a Steam Vessel from Portsmouth on the 12th of June. In consequence, however, of the late vigourous manifestations of loyalty by the army of Oporto, it is supposed the return of the Nobility to that City now will not be likely to produce any singular advantages; whereas had they not quitted the place at all, their weight and influence would no doubt have been more beneficial to their country, tho' perhaps, dangerous to themselves: while, on the other hand, the mere circumstance of the emigration of such distinguished individuals from their native Highlander, Barret, Belfast, 42-R. Rankin & Co., passenhomes, strongly shews how violent must have been the Revolution, and how fearful in the consequences which it threatened, that could have led to circumstances of so painful a nature.

Melancholy Circumstance.—On Saturday evening last, Mr. John H. Peters, (fourth son of William) Peters, Esq., of this Town,) in company with another, having taken a Boat, with a coloured man to mind it, and put off from the shore, near the landing of Mr. Samuel L. Peters', in Queens County, for the purpose of bathing; the coloured man, while Mr. Peters and his companion were in the water, ran the boat near the bank among some Eel grass, where supposing the water to be shoal, he stripped and jumped in ; but, unfortunately, the contrary proving to be the case, and Mr. Peters seeing him in a sinking state, went immediately to his assistance, and the man being far gone, Mr. P. seized him, and after making every exertion to save his life and bear him to land, they both sunk together and were drowned even before the other man could reach the place. They had not succeeded in finding the bodies when the account left there on Sunday morning, and some fears were apprehended

in this respect, as they were both naked, and the year of his age.

We have since heard that the bodies have been seen in 25 feet water, lying a short distance from each other.
