It is with the highest satisfaction we are enabled this day to promulgate an order of the Master General of the Ordnance, relative to a branch of the military service of the country, not more distinguished by their untarnished gallantry and eminent services, than by the universal esteem in which those characters, as private individuals, are held wherever they become known....we mean the *Royal Artillery*. The following is the Order :—[*John Bull*.

GENERAL ORDER, NOV. 6.

"The Master General has the honour of announcing to the Officers of the Royal Artillery, that His Majesty, anxious to give a proof of their long, faithful, and gallant services, has been graciously pleased to direct that the following arrangement shall be carried into effect :—

"The regimental rank of Major is abolished, and the number of Lieutenant-Colonels is augmented to the proportion of one to a Battalion, upon Major's pay. They are to be posted accordingly; and if necessary, are to be transferred to the Battalions when they arrive at the increased pay. 2nd. During three years from the date hereof, Four Field Officers, who, from age, wounds, or other circumstances, may be desirous of retiring from the service, will each year have the indulgence upon the same principle that was allowed under the order of the 27th of May, 1823. To effect this object for the first year of the period, those Officers who are desirous to retire, will send their names to the Deputy Adjutant-General, on or before the 10th of December, when a selection will be made in the manner best suited to meet the spirit of His Majesty's gracious intention. 3d. The General Order of his Royal Highness the late Commander-in-Chief, of the 27th of December, 1826, is to be made applicable to the Royal Regiment of Artillery, under the following regulations :—The forty-three Field Lieutenants, serving upon full pay, whose commissions are dated previously to the 1st of January, 1812, shall have the option of being promoted to the unattached rank of half pay, of five shillings per diem, and as vacancies occur, to return to the full pay as Second Captains of the Corps in the order they now stand in the List. The Officers in question to be allowed one month from the date of their receipt of this communication to consider whether they will or will not avail themselves of the promotion; and if they allow that period to elapse, without forwarding their decision to the Deputy Adjutant General, it will be considered that they wish to serve on full pay as Lieutenants of the Corps. It must be understood that no retrospect will be admitted after the expiration of the above period.

His Majesty has been pleased to sign the following Commissions in the Royal Regiment of Artillery :—To be Lt.-Colonels :—Majors Edward Wilmet, James Mac-lachlan, James Adams, William Roberts, Thomas Patterson, William Morrison, William Cleeve, Nathaniel Oliver, G. H. Godby, P. St. Clair.

From the Paris Monitor, Nov. 10.

The affair of the East is terminated. The *Journal des Debats*, of this morning, complains, that for a long period the cry of victory had not been heard. Its complaint was only made in time to be drowned in the acclamations of the public. On the 6th of July the three maritime powers resolved to clear and to pacify the Mediterranean. On the 20th of October the reflection of the fire which destroyed the Turco Egyptian fleet, glared on the walls of Modon.

At a single blow the contest which has shocked humanity during the last four years, has been finished!—by a single blow peace has been restored to the world!

All is done, and the docility of the Porte, and that of the Greeks, will follow the re-establishment of commerce, the maintenance of the European equilibrium, and even the advancement of civilization in Egypt.

While that the Archipelago breathes from that dread of sudden incursions, which kept it in a state of incessant agitation, like the inhabitants of a place near a cavern, who expects every moment to behold wild beasts springing on him, the Morea has thrown on the liberated sea glances full of terror. The road is closed against the auxiliaries of its oppressors, and the yoke which overwhelmed it is removed.

Can the Turco Egyptian army hope to maintain itself on the scene of its ravages after the destruction of its fleet? Must it not be too happy to obtain facilities for an evacuation, which becomes henceforth its only resource? One single event has dried up the two sources whence the Porte drew its means; the same sword has cut off the two breasts of this war.

And, henceforth, the Greeks, emancipated, will cease to disturb and harass the commerce of Europe; piracy will no longer have a pretext or excuse.

The Paris *Journal des Debats* states, that Count Capo d'Istria, the new President of Greece, has given up his private fortune to the public cause, and procured a small loan for the treasury, which would answer immediate exigencies. His letter on the subject breathes the most generous devotion. On the 18th of October the Austrian Admiral Dandolo presented himself before the harbour of Spezzia, and claimed four Austrian vessels, which had been captured by the Greeks for a violation of their blockade. When it was replied that the matter would be submitted to the Greek Government, he rejoined that he knew no such Government. After seizing on the 19th, the four vessels, he sailed in upon the Greek vessels, in the harbour, cannonaded and tore them to pieces, killed a portion of their crews, and did much damage on shore. There is an official report from Spezzia, in the Paris newspapers of this enormous outrage.

Philadelphia, Dec. 19. Captain McElin took, and the surviving crew of the brig *Try Again*, (13 in number) being indebted, under Providence, to Captain S. Baldwin of the packet ship *Alexander*, of Philadelphia, for the preservation of their lives, beg leave to express their gratitude, by publicly acknowledging the obligations they are under. The *Try Again* sailed from Quebec, 11th October, bound to Liverpool, with a cargo of timber. On the 22d, in lat. 45. long. 33. were overtaken by a severe gale. During the day she laboured much, and shipped a deal of water. At 3 P M on the 24 h. shipped a sea which swept the decks fore and aft, leaving nothing standing but the foremast and stump of the mainmast. Two of the crew, James Robinson and Duncan Weir, were swept over and drowned. After clearing the wreck, we found the ship half full of water, and totally unmanageable, having lost her rudder. We then prepared some provisions for the purpose of securing ourselves on the foretop, but had no sooner placed them on deck than they were swept off. We were then obliged to return to the top without food or water, and there remained for four days. On the morning of the 5th, being nearly exhausted, and the weather more moderate, we went on deck in search of provisions. Two casks of water had been stowed in the steerage, and one with difficulty was brought on deck, which had been stowed and a quantity of salt water admitted; we however secured it to the windlass, and with sixteen pounds of beef repaired again to the top, where we remained 11 days, during which time ten vessels passed us, one in particular within musket shot, but to our great surpris, she altered her course and stood from us. Our beef now being exhausted, and having no-

thing left but this brackish water, our sufferings became very great. Some of the crew then suggested that lots should be cast for one to die for the sustenance of the others, but two not agreeing, we were fortunately preserved on the 20th Nov. by the ship *Alexander*, Captain Baldwin, who sent two boats to our assistance. At this moment our feelings may be imagined, but not told. By the kind treatment of Capt. Baldwin, we have been saved from a watery grave, and rescued from one of the most distressing scenes that can be presented to imagination.
