

" A Bill to provide for the services of the Speaker of the House of Assembly, and for defraying the expences and travelling charges of the Members, of the said House attending in General Assembly.

" A Bill to alter and amend the Laws now in force for the regulation of the Militia.

" A Bill in addition to an Act, intituled An Act to empower and authorize the Justices of the County of Westmoreland, at their General Sessions of the Peace, to regulate the grazing and depasturing of the several marshes, low lands or meadows within the said County.

" A Bill to lay a Tax on Dogs in certain parts of the Parishes of Fredericton and St. Andrews.

" A Bill for the erection of a Court House and Gaol in the County of Kent.

" A Bill to authorise the Justices of the Peace of the County of Kent, to make Rules and Regulations, respecting the taking of Fish in the different Harbours, Rivers, and Creeks, in the said County.

" A Bill to empower the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of St. John, to dispose of lots in the new burial ground in the vicinity of the said Parish.

" A Bill in amendment of the Acts regulating the exportation of Fish.

" A Bill further to amend the Act for regulating Elections of Representatives in General Assembly.

" A Bill to repeal the Law now in force for appointing Firewards, and for the better extinguishing of fires in the Town of St. Andrews, and to make regulations more suitable to the said Town; and for other purposes therein mentioned.

" A Bill to regulate the Trial of controverted Elections, or returns of Members to serve in General Assembly.

" A Bill to continue until the 1st day of April 1833, an Act to regulate the Manufacturing and Shipment of Grind Stones, from the County of Westmoreland.

" A Bill to continue an Act, intituled, An Act for the encouragement of Parish Schools in this Province.

" Bill to continue and amend the Acts for the encouragement of the Cod and Scale Fisheries.

" A Bill for granting a bounty upon Flour manufactured at the Steam Mills in Portland."

After which His Excellency was pleased to make the following Speech :

" Mr. President, and Gentlemen of His Majesty's Council :

" Mr. Speaker, and Gentlemen of the House of Assembly :

" I thank you in His Majesty's name for the liberal appropriations you have made for the services of the present year. I acknowledge with the highest satisfaction the diligent attention you have shewn to all the measures which I particularly recommended to your consideration, in the course of the Session; and for the ample provision you have made to promote those important objects.

" You may rely upon my utmost endeavours, to secure a faithful and provident application of the means you have thus placed at my disposal.

" I have witnessed with infinite satisfaction, the zeal, wisdom, and uninterrupted harmony, which continue to inspire and animate the Legislature of New-Brunswick; and I am sure that you will cultivate, in your respective circles, those sound principles of loyalty and affection to our Most Gracious Sovereign, and attachment to the Parent Kingdom, which you evince in the discharge of your high duties here, and

which only can promote and secure the real interests of this rising Colony."

That His Honor the Chief Justice then said,

" Gentlemen of the Council :

" Mr. Speaker, and Gentlemen of the House of Assembly :

" It is His Excellency the Lieutenant-Governor's will and pleasure that this General Assembly, be now prorogued until the third Tuesday in June next, and this General Assembly is accordingly prorogued until the third Tuesday in June next.

West Indies.—The London Gazette of Jan. 29, contains a Proclamation authorizing the export of fish and fruit from the island of Anguilla, in the West Indies, in vessels of the U. States, that arrive there in ballast, to take effect as soon as the same shall be made known to the Governor of St. Christopher.

The Governor of the Bahama Islands has opened them for the exportation of salt & fruit, in American vessels arriving in ballast. His Proclamation bears date 22d Feb. 1828.

An important subject connected with the colonial interests, we understand, will shortly be submitted to the consideration of his Majesty's Government; namely, a proposal for "unrestricted trade between the British W. I. Colonies (having warehousing or free ports) & the British Fisheries and Provinces in N. American and Bermuda, by the removal of all duties on the import of sugar, rum and molasses, into the latter; also between the former and the ports of Germany, (Hamburg and Bremen) in the vessels of these States, importing the produce of Germany, in order to compensate the W. India Colonies for the loss of the trade with the United States of America.

Whilst the Assembly was in Committee on the Transient traders' Bill, the Speaker said he intended to frame a Bill, to be introduced next quarterly meeting, laying a duty on the importation of all kinds of lumber and provisions, the productions of the Canadas, and of the Provinces of Nova Scotia and New-Brunswick; equal in amount to one half the duty now imposed on similar productions of the U. States. This duty to continue till His Excellency the Governor shall receive authentic information that the Legislatures of the British Provinces have repealed all duties imposed by them on sugar, rum, and molasses, the produce of this Colony. This the Speaker said, would be in strict conformity to Mr. Huskisson's plan of reciprocity in our intercourse with all countries. At present, heavy duties are levied in the Canadas and Nova Scotia on West India produce, in some cases almost amounting to a prohibition; while at the same time, their lumber and provision are admitted throughout these Colonies free of all impost whatever.
