St. Andrews, August 11.

His Excellency Sir Howard Douglas, Lieutenant-Governor of the Province, arrived here on Tuesday last. He was met several miles from Town by many of the principal inhabitants, on horseback, &c. He arrived at his quarters about four o'clock, where he was received by a guard of honor, consisting of a detachment of the 81st Regiment, under the command of Ensign JEFFERY, and the Militia Rifle Company, commanded by Captain Boyn. A large concourse of people had assembled on the occasion, and greeted his Excellency with hearty cheers. We were gratified to find His Excellency looking so well.

The Honorable Judge Borsforr, & THOMAS MURRAY, GEO. F. STREET, and NEVILLE PARKER, Esquires, Barristers, have arrived in Town. The Supreme Court commences its sitting tomorrow.

In the House of Commons, on the sixth of June, Mr. Dawson moved that £16,182 be granted to the Society for the Propagation of the Gospel in Foreign parts. It was for the first payment of the Missionaries of the Church of England. Mr. Hume strongly objected to the vote. He contended that as the great majority of the inhabitants of the Canadas were Roman Chatholics, Church of England Missionaries were worse than useless, and concluded by moving as an amendment, that the sum of 8,0001. should be inserted instead of 16,1921 .- The Chancellor of the Exchequer said that in Nova Scotia there was a clear majority who belonged to the Church of England .- Sir R. Inglis supported the grant. Sir T. 

The Bodies of Mr. John Peters, and the colored man who were drowned on the 9th inst., as noticed in our last, were picked up on the following day.

We learn that on Thursday the 14th instant, a dead body was found by the children of Mr. Samuel Thorn, floating near the mouth of the Rev. Samuel Clarke's Creek, at the entrance to Gage-Town, which proved from the dress, and the name "I. Samuel" on the inside of the Jacket, to be the body of a Soldier of the S1st Regt. A Coroner's inquest was held the followingday--Verdict, " Found Drowned."
