selves, let them do so by all means-let us oppose no unreasonable barrier-let us profit by past experience-let us beware of a contest, whose remote consequences we are unable to foresee. If separation there must be, let England manage that it shall be effected with as much advantage to the interests of both parties as circumstances will permit. Let both countries avail themselves of their common origin and their commen interests, to cement a friendly intercourse, and establish a strict alliance, mutually beneficial, and calculated to promete and to perpetuate the independence of the New World. He urged these considerations apart from any thing of mere national or selfish views, apart likewise from that which was greatly subordinate to these-the patronage connected with those colonies .- N. Y. Albion, Aug 30.

Mr. O'Connell has been elected for Clare by a very large majority over Mr. Vesey Fitzgerald. The circumstance produced a great excitement throughout Ireland. As Mr. O'Connell will not, of course, take the prescribed oath, his election will ber. be void, and Mr. Fitzgerald being the next highest on the poll, will resume his seat in the House of Commons. It should be recollected, that Mr. Fitzgerald has always been a stern and inflexible friend to Ireland, and a warm advocate for Catholic Emancipation. The opposition to him, and the abusive language he received on the Hustings, seems a little singular; for the most violent opposer of the Catholics could not have received more unwarrantable treatment than this excellent man did from Mr. O'Connell. Conscious of his innocence of all that was laid to his charge, stung with ingratitude, and under the excess of his feelings, he exclaimed, Loch-brig Amwell, Aberdeen, 25, to George Taylor. "Do I deserve this treatment?" The Catholics, nevertheless, out voted him, and he is left to enjoy the bitter reward of their ingratitude. His crime was, that he joined the Duke of Wellington's ministry, and accepted a situation in which he could be really and essentially useful to his country! and the Mary, Morrison, Aberdeen; Elizabeth, Morris, Kirkaldy Duke of Wellington's offence, it would seem, was, that he appointed a friend of the Catholics to one of his most important offices. How true it is that Ireland's worst enemies are to be found within her own bosom.—Ib.

WHEREAS it appears to this House, that the Accounts rendered by Commissioners of Monies expended on the Bye-Roads and Bridges, are frequently not sufficiently particular and explicit; but that this in general proceeds from ignorance of what is required, and not from wilful neglect or default : Thereupon Resolved, that it is the opinion of this House, that, " The Commissioners of Byen Roads and Bridges, in making up their accounts of Monies expended, should state in such accounts.

1st .- " Whether any, and what parts have been done by Con tract; and if so, the names of the contractors, the nature of the Contract, whether so much per Rod, or other distance; or so much for the whole; or in what other way; how the contract has been performed, and what sums have actually been paid.

2d,-" If done by days work, to state the names of the workmen; the rate of wages per day, of each man; whether found in provisions or not; the number of days which each man has worked; the amount paid each man; the quality of work done; and the mode in which the same has been performed.

3d .- " The proper receipts should accompany the Accounts of all Monies paid by the Commissioner; and if the same are signed with a mark, they must be witnessed by at least one respectable

4th. - The Commissioners accounts should be attested to, before a Justice of the Peace; and the oath to be in the following form or to that effect : "We, A. B. & C. D. the Commissioners within named,

" do make oath that the foregoing account is correct and true, and " that the several sums therein mentioned as paid, have actually been " paid by us, as therein stated.
