SUPREME COURT.

Hilary Term, 5th February 1828.  
William Carman, Esq. having taken the usual oaths was this day called to the Bar and enrolled a Barrister of this Court.

On Tuesday last a Court of Oyer and Terminer, and General Gaol Delivery, for this City and County, was opened by Special Commission. His Honor JUDGE CHIPMAN, presided.

Patrick Burgan was arraigned to take his trial for Burglary. The crime (the particulars of which we noticed some time ago) was clearly proved against him. Sentence, Death.

Burgan, from his appearance, seems to be a young man, probably not more than 18 years of age. His Honor the Judge, in pronouncing sentence, seemed to be deeply affected with the awfulness of the scene. Indeed, the only person in Court, who appeared to be unaffected was the prisoner himself. Though solemnly warned not to hope for a reprieve, and that his instant duty was to prepare to "meet his God," he exhibited every symptom of youthful indifference. Such instances of youthful hardness are calculated to make one shudder: We hope for the credit of humanity, and the great pains now taken to disseminate the principles of Religion, that in this community they are few. We understand he is ordered for execution on Thursday the 21st instant.—*Courier, 2d inst.*

GAOL LIMITS.

AT a Special Session of the Peace of our Lord the King, holden at the County Court House in Fredericton, in and for the County of York, on Friday the 1st day of February, 1828.

IT IS ORDERED, that in future, the Limits for the Gaol of the said County, under the Act of the General Assembly, 4th Geo. IV, Cap. 10, be as follows, that is to say:—

Commencing at the waters edge of the River St. John, where a continuation of the Southerly line of St. John Street would intersect the same, thence along the said line to Province Row, thence along the East side of Province Row to the side walk on the North side of Church Street, thence along the said side walk to Brunswick Street, thence along the Westerly side of Brunswick Street to St. John Street aforesaid, thence along the Southeasterly side of St. John Street to George Street, thence along the Westerly side of George Street

to where a continuation of the Northerly line of Carleton Street would intersect the same, thence along the said continuation line of Carleton street aforesaid, through the Burying Ground to Brunswick Street aforesaid, thence along the Westerly side of Brunswick Street to where a continuation of the line between Lots Nos. 125 and 126, owned and occupied by B. S. Williams, and Lots No. 127 and 128, owned and occupied by William Bailey, would intersect the same, thence along the said line and a continuation thereof across King Street, and to the Easterly side of Queen Street, thence along the Easterly side of Queen Street to Carleton Street aforesaid, thence along the Northerly side of Carleton Street to the waters edge of the River St. John, and thence along the said waters edge to the place of beginning.
