The Emperor Nicholas has addressed a Circular to all the European Courts, referring to the Declaration and Manifesto he has issued on the subject of the war with Turkey, and confidently relies on their approbation of his conduct. He indignantly repels the suggestions propagated by malevolence or fear, to excite alarm, that the general peace of Europe is menaced, and that Russia has ambitious views; and peremptorily declares, that the treaties between Russia and the Porte may be renewed in such a manner as to be completely efficacious; including securiry for the future, the free navigation of the Black Sea and Bosphorus, and indemnity for the expenses of the war, and the losses sustained by her subjects. He reiterates, that he has no ambitious views-no wish to diminish the Ottoman Power, and that he will require no sacrifice from Turkey but in the spirit of equity and moderation. In proof of all this he refers to a letter sent to the Grand Vizier, which completely demonstates, he says, that it is entirely in the power of Turkey to make peace with Russia; and from St. John, for London. that on the one hand, as Russia will not suffer a negotiation to be so prolonged as to lose the advantage of an entire campaign; so on the other, her sole thought is how best to open the means of a reconciliation at once speedy and durable. Wallachia, and has Belgrade (so often alluded to in former wars) as its key towards the German Empire. It was conquered by the Turks under Mahomed the Great, soon after he made himself master of the Greek Empire, by the capture of Constantinople in 1453. Since the deslender hold on the allegiance of the Servians, who have made several attempts to throw off their yoke. In these attempts they were frequently aided by Russia; but in consequence of the former mutual jealousies of the European powers, they were eventually left to their fate. During the French Revolution, and particularly during the military sway of Bonaparte, they again attempted to emancipate themselves; and about 1811, a French army, under Marshal Marmont, we recollect, was on the point of marching from Dalmatia to their assistance; when the entire overthrow of the French armies in Russia and Spain compelled the French to return to their own country, and leave the poor Servians to the chastisement of the masters. After the overthrow of the Military Despotism of France, it became the policy of the victorious Allies not to interfere hostilely in the internal affairs of the nations but Russia, in all her treaties with Turkey, has made stipulations for the good treatment of the Servians as well as of the Greeks of the Principalities .- It now appears that the Servians were making now attempts to rise against the Turks, and one of the objects of the new war waged by Russia, is to preserve the tranquillity of the province
