WHEREAS the General Assembly of this Province stands prorogued to Thursday the twenty fourth day of this instant January: I have thought fit further to prorogue the said General Assembly, and the same is hereby further prorogued to Thursday the fourteenth day of February next—then to meet at Fredericton for the dispatch of business.

AN ORDINANCE.
HOWARD DOUGLAS.

WHEREAS the times of holding the Hilary and Easter Terms of the Supreme Court, as established by Ordinance, bearing date the twelfth day of February in the year of our Lord one thousand eight hundred and ten, have been found inconvenient, I have therefore thought fit, by and with the advice and consent of His Majesty's Council, to ordain and declare, and I do by these presents ordain and declare that the said Hilary Term shall in future commence on the first Tuesday in February in every year, and the said Easter Term, on the first Tuesday in May in every year, instead of the Third Tuesday in February and May respectively, as established by the said Ordinance; and the said Terms shall continue from the said Tuesdays, respectively, until the Saturday following, on which day they shall respectively end, unless the Justices of the said Court shall adjourn the sittings thereof to the Week succeeding the said Terms respectively, under the provisions of the Act of Assembly in such case made and provided; and of this Regulation His Majesty's Justices of the Supreme Court, and all others whom it may concern, will take due notice and govern themselves accordingly.
