

bow, always keeping the Light on the beach open, and on the starboard bow.

Vessels coming from the Westward will see this Light when they are as far to the eastward as Chebucto head: by keeping it open on the starboard bow it will lead them up to the beach.

This Light, will appear of a red colour, which will distinguish it from any other on the coast. It is fifty eight feet high from the level of the sea.

CHARLOTTE COUNTY AGRICULTURAL AND EMIGRANT SOCIETY.

HIS EXCELLENCY SIR HOWARD DOUGLAS, BART., PATRON.

At the Annual Meeting of the Charlotte County Agricultural and Emigrant Society, on the 8th instant, the following Report of the President and Directors was read and unanimously accepted.

REPORT.

The Eighth Annual Report of the Charlotte County Agricultural and Emigrant SOCIETY.

SINCE the last Annual Report nothing unusual or peculiar has transpired, materially to affect the Agricultural interests of this County, but the President and Directors have great pleasure in being able to state, that a gradual improvement in the mode of cultivating the soil is apparent, and the importance and necessity of making it the principle dependence on which to rely for subsistence, appears to be better understood and more generally admitted, and they flatter themselves that this Society has, in some degree, been instrumental in producing this result. They cannot, however, refrain from expressing their decided conviction, that those efforts are neither fully understood or appreciated.

The President and Directors have appointed a Committee to provide such quantities of seeds for the use of the Society the ensuing season as may be deemed necessary, and they are happy to say that so excellent are the Oats raised in the County from the seed imported by the Society, that it is not considered necessary to have recourse to other

Countries for a further Supply at present... but notwithstanding the very important attainment, they regret that the Oat-Mill erected in Saint David, for which a Bounty was given by this Society, does not appear to be in useful operation, although the proprietor appears to have fulfilled his contract in every respect, and the meal which has been manufactured there has been of excellent quality.

The President and Directors have purchased from the Central Society, at a considerable expense, a Bull and a Ram, of the most approved breeds, imported from England, which they trust will be found an useful acquisition, but as there is already an excellent breed of Horned Cattle in the County it may become a question whether, hereafter, the funds of the Society may not be better appropriated in the purchase of implements of Husbandry and for other purposes tending more immediately to advance an improved system of cultivating the soil.

The successful attempt made in establishing a Cattle Fair at Saint Andrews in November last, has led to the conclusion that a Cattle Show might be united with the Fall Cattle Fair, and the President and Directors recommend that prizes may be awarded for that purpose, being of opinion the same will promote the general views of the Society.

Your Secretary has been in correspondence with the Commissioner of Crown Lands on the subject of appropriating tracts of Land for the use of Emigrants, and the President and Directors have the satisfaction to state that the suggestion was favourably received and has met with the approbation of His Excellency the Lieutenant Governor, and that a Warrant of Survey has been ordered to be issued, to lay out certain Lands between True's on the Fredericton Road and L'Etang, reserving portions of the same for the well founded claims of the old Seulers; and the President and Directors are in expectation, that by the ensuing Spring, a system will be devised and adopted, to render it practicable to afford a sufficient inducement to respectable Emigrants to remain in the County; hitherto all that the Society could do for them was to supply gratuitously, small quantities of Seeds.

The Treasurer's account will be laid before you, by which it will be found, that the finances of the Society are in a prosperous state, but requiring the constant attention of its officers.

The President and Directors in conclusion, most strenuously recommend a steady perseverance in the good cause, in which the Society has embarked, and trust that renewed efforts and continued perseverance will overcome the obstacles still impeding its legitimate course to extended and practical improvement, and ultimately attain the grand object of this formation...the prosperity of the Country in which we live.
