

ford Canning demanded a firman, in order to forward it to his government, and take its orders. The firman was refused. The French and Russian Ambassadors did not think fit to expose themselves to a similar refusal.

The Imperial Palace at Adrianople was preparing to receive the Sultan, who will go there when he puts himself at the head of the army.

Troops and ammunition have been sent to Sillistria to put the fortresses on the Danube in a state of defence. The principalities are given up as not capable of being defended.

EXECUTION OF BURGAN.

On Thursday morning last, the awful sentence of the Law was executed on the person of *Patrick Burgan*, who was convicted at the last Court of Oyer and Terminer, of Grand Larceny. On account of his youth, being only 18 or 19 years of age, no ordinary sympathy was excited in the public mind.—He was attended by the Rev. Messrs. CARROLL and M'MAHON, of the Roman Catholic persuasion, and much credit is due these Gentlemen for the interest they took in his behalf, not only in endeavouring to prepare his mind for meeting his awful fate, but in using every exertion within the compass of their power to save him from it. Mr. Carroll went to Fredericton with a representation to His Excellency the Lieutenant-Governor, for the purpose of obtaining a reprieve, or at least a mitigation of the sentence. This representation was made to His Excellency in the form of a petition and signed by a large proportion of the most respectable inhabitants of the city.

We understand that *Burgan*, previous to his execution, confessed his being guilty of the crime for which he was sentenced to die—also that previous to his leaving Ireland he had lived with his Grand Mother:—That he had robbed her of some Cattle, sold them, and brought the produce of their sale to this Country with him.

We trust an example such as this will not fail to be a warning, especially to young persons, how they tread upon the threshold of iniquity. When once the limits of conscience are trespassed, none can tell what the end of such a course may be.—Every fresh violation of its dictates only tends to harden the sinner and prepare him for committing at length such enormities as he would at first have shuddered at. He goes on apparently unconcerned step by step till destruction overtakes him when he least looks for a check to his career. He may even escape the hand of justice in this life, but should he persist and die in impenitence, nothing can save him from that awful retribution which awaits evil-doers in the world to come.—*Courier, Feb. 23.*

HIGHWAY ROBBERY.

On Friday last, the 15th inst. a Pedlar named *Parks*, who had been some distance in the Country, and had disposed of his wares, was on his return to St. John with the proceeds thereof about his person, in Cash and Bank Notes. At he was crossing the Portage from Seely's Point to the Kennebecasis, he was overtaken by two men, one armed with a pistol, and the other with a long knife. They succeeded in robbing him of his money, about twenty-one pounds, and made the best of their way back. *Parks* describes one of them as being about 5 feet nine inches, dark complexion, long face, and large whiskers, dressed in homespun Jacket and Trowsers...the Jacket, he thinks,

striped...The other, about 5½ feet, fair complexion, dressed in homespun blue Jacket and brown Trowsers...the knees worn and ragged. *Parks* having arrived at a house about the middle of the Portage, related the circumstance, when the inmates immediately accompanied him in returning to make search for the depredators, and traced their footmarks, as they thought, in the snow, to the Main River, but were finally unsuccessful in making any discovery. An information was immediately lodged with Mr. Justice Haviland, who directed hand bills to be posted at the most public places in the neighbourhood, and a general search was set on foot, but as yet without effect.

One of the Bank Notes taken from *Parks* was of the Saint Andrews Bank, and was endorsed by some person on the back. This circumstance may lead to the identification of the money; the rest being in St. John Bank Notes and Silver, may not be sufficient evidence, should the thieves be caught, to lead to conviction of the crime. We trust, however, that magistrates and all persons in authority will be on their alert, in order to bring this daring robbery to the proper source. The utmost vigilance is now requisite, for crimes of this nature are becoming alarmingly common in the Province.—*ib.*
