A New-York Paper of the 12th instant, furnishes London dates to the 16th, and Liverpool to the 17th ult. inclusive. The Liverpool Courier reports the arrival of the Turkey Mail with letters from Constantinople of the 11th, and from Smyrna of the 4th of march. Nothing particular had taken place since the preceeding advices. Preparatory measures of defence were continued in the Capital, but not with such vigour as might imply either a full conviction of approaching danger or a final determination to oppose a fixed resistance to it. The Liverpool Courier adds-"There are letters from Odessa, dated the 21st ult., according to which no possibility of a doubt remained as to the approaching invasion of the principalities by the Russian Troops."

A Brussels paper estimates the whole Mlitary force of Russia at 700,000 men, 300,000 of which are in motion.

In the Militia General Orders published last week, under Saint John City Militia, for "Monday 16th September" read Monday 15th September.

We must decline publishing the letter respecting a transaction which took place in the Supreme Court last Term, as we consider that our compliance with the author's wishes might only involve him in difficulty.

Z is referred to the Post Office notice published in today's Gazette.

Chaincook (or perhaps more commonly called Greenlaw's) o'clock on that day Dr. De Wolfe, of this place, was near the barn of Mr. D. Smith, when suddenly he heard a violent and alarming noise like that of an earthquake, but not accompanied with any tremulation of the earth; and immediately afterwards a large quantity of smoke (but he could preceive no flame) was emitted from the mountain, proba-Smith the wife of D. Smith (who was at home) states, above the trees; Dr. D. W. thinks, scarcely so high; and this was repeated at short intervals, three times. They were both much alarmed, and did not think it prudent to go towards the spot from whence the smoke ascended. But since that a party of Gentlemen from St. Andrews-have explored the mountain, but could find no tract to cause the belief that it was a volcanic irruption; but so strong is the impression on Dr. De Wolfe's mind, that his opinion is unalterably fixed, that it was so. - The day was calm and cloudless. Our own opinion is, that it was a whirtwind, and

in this belief we are strengthered, from the circumstance, that on the same day, and near the same hour, about five hundred weight of paper which was drying at Chamcook Mills, was carried into the air by a whirlwind and dispersed in all directions; some of it fell on the top of the mountain. It may be proper to add that in February last, Soloman Brown, his wife and George Greenlaw, neighbours to D. Smith, declared in most positive terms, that they saw blaze emitted from the mountain, about a quarter of a mile from where Dr. De Wolfe saw the smoke ascend, and that it was accompanied by a noise similar to what the Dr. states he heard.
