Lady Douglas still continuing to improve gradually, we confidently hope we shall, ere long, have the satisfaction to hear that her Ladyship is perfectly restored to health.

We are happy to hear that Captain Douglas arrived at Government House on Friday last, from Washington.

About ten o'Clock this morning a fire was discovered on the roof of the Archdeacon's Residence, which had ignited either through an aperture in the Chimney communicating with the rafters, or from some sparks falling upon the roof, the chimney having been on fire just before the accident: But in consequence of prompt assistance, no material injury, we are happy to say, was sustained.

We lament to learn that the brig Ann-Maria, of and from New-York, bound to St. John, was lost on the 19th ultimo, about four miles from Mainicus Island, when all on board (ten) perished John Smith, an Englishman, was previously washed overboard, and afterwards providentially saved.

The last Halifax Mail has furnished us with English dates, to the 8th of February, and the intelligence is of very interesting importance. Lord Goderich having resigned, a new Ministry was immediately formed with His Grace the Duke of Wellington at its head, who has, it appears, in consequence wholly relinquished the Command of the Army. The Imperial Parliament was opened by Commission on the 29th of January. His Majesty, in alluding to the circumstances connected with the affair at Navarino, "deeply laments that this conflict should have occurred with the naval force of an ancient Ally, but he still entertains a confident hope, that this untoward event, will not be followed by further hostilities, and will not impede that amicable adjustment of the existing differences between the Porte and the Greeks, to which it is so manifestly their common interest to accede". On this point, it seems that in the debate which took place in the House of Lords on the motion for an Address to His Majesty, in answer to the speech, the members of the Administration, and Lords Lansdowne and Goderich, disclaimed all attempt to censure Sir Edward Codrington.

LONDON, FEBRUARY 1.

Lord Goderich has resigned, and the late Ministers, with but two exceptions worth notice, namely, Mr. Huskisson and Lord Dudley, have been succeeded by Ultra Tories. The Duke of Wellington is Prime Minister. Mr. Herries has the Mint. Mr. Goulburn is Chancellor of the Exchequer. Lord Ellenborough is Lord Privy Seal. Lord Aberdeen, Chancellor of the Duchy of Lancaster. Lord Lyndhurst remains in office as before. Earl Bathurst is President of the Council. Lord Melville is President of the Board of Control; Mr. C. Grant of

Trade. Lord Palmerston, Secretary of War. Lord Dudley is Foreign Secretary; and Mr. Huskisson has the Colonies.

The Hon. W. Carr Viscount Bessborough G. C. B. has been appointed Master General of the Ordnance.

The Right Hon. Sir John Beckett has been appointed Judge Advocate General.

H. M. Ships Alligator and Cyngel have arrived in England.

It is said that Lord Wellesley will resume the Government of Ireland.

There has been a decrease in the Revenue during the year ending the 5th ult. of £5,993.

The accounts from the Manufacturing Districts are represented as favourable.

It has been announced that the dividends due upon the Buenos Ayres Loan, will not be paid.

Insurrection still continues in some parts of Spain.

In the Debate which took place in the House of Lords on the motion for an Address to His Majesty, in answer to the Speech, the Members of the Administration and Lords Lansdowne and Goderich, disclaimed all attempt to censure Sir Edward Codrington.

The Hon. Edward Stanley attended at the Colonial Office yesterday, and resigned his situation as Under Secretary of State for that Department.

The Marquis of Anglesea has been confirmed by the new Ministry in his situation as Lord Lieutenant of Ireland.

The Orestes has arrived in Chatham, where she is to be paid off.

FEBRUARY 8.

The Right Hon. Robert Peel, Secretary of State for the home Department, took the Oath and his Seat last evening in the House of Commons. Previous to the adjournment he gave notice that, on Tuesday next, he should move for the appointment of a Committee to consider the state of the Financial Expenditure of the Kingdom.

HALIFAX, March 8.

The Right Reverend the Lord Bishop held ordination on Sunday Morning last at St. Paul's Church, when the REV. ALEXANDER CARNEGIE SOMERVILLE, M. A. Deacon, of Bathurst in the Bay Chaleur, was admitted into the order of Priests.
