## Sale of Crown Lands.

DISTRICTS, No. 1, 3, 4, 5, 7, 8, 9, 13, 14.

BY order of His Excellency the Lieutenant-Governor, Public Notice is hereby given, that various Tracts of Vacant Crown Land will be offered for Sale, by Auction, at the undermentioned times and places, subject to the regulations formerly published, and to Conditions of cultivation and improvement similar to those expressed in the Grants heretofore passed.

At Gage-Town, on Thursday the 11th of September, 1828.

A Number of Vacant Lots on the Nerepis Road and Stream, and in the Vicinity of the numerous Settlements between the said Stream and the River Saint John, and Vacant Lots in the Vicinity of the Grand and Washedemoac Lakes and their tributary Streams.

At the Finger Board, on Saturday the 13th of September.

## ALARMING INSTANCES OF HYDROPHOBIA.

Our correspondent from the country informs us that at the French Village scarcely a dog has escaped this dreadful malady, five or six dogs have been shot, to prevent further mischief. A child has been bitten, and the suspense and agony of the parents are truly pitiable. Mr. Beattie has buried (alive) a cow that was bitten by one of those rabid creatures. A pig has also been bitten, but has not as yet shewn any symptom of disease. At Hampton and in Sussex Vale, a number of dogs have been shot, and to such an alarming height has the panic risen, that persons are afraid to quit their houses—as in all probability ere long some of those diseased animals will visit the city. Persons who have dogs they wish to preserve, should keep them confined until the danger is past ; and as we have a corporation law for destroying all dogs that are not taxed, and that go at large without collars ; we think it would be a desirable mark of vigilance in the persons whose business it is, to exterminate a few scores of the whelps and curs with which the city is at present infested, and prevent as far as in their power the calamity from spreading.—B. ## Attempt to Assassinate the King of France.

It appears by the French Papers received this morning, that an attempt was made on the life of the King of France :-

"Paris June 21.—On the 18th inst. a man of about thirty years of age, cleanly dressed, and appearing to belong to the working class, presented himself at St. Cloud, and asked to be introduced to the King. He persisted ; but his demand was refused. He then went away, and proceeded to an inn ; but the violent Speeches he made against his Majesty and the Royal Family were so offensive that he was taken up, and two pistols loaded with bullets found upon him. He had also powder and balls in his pocket.

"He declared upon his examination, that his name was Pernet ; he mentioned his place of abode, and in it was found a large quantity of powder and ball.

"He was interrogated to-day, (21st June) by one of the Judges of Instruction."

THE Subscriber feels it his duty to publish the following RESOLUTIONS of the House of Assembly, passed in the year 1826, and requests that the Commissioners of Bye-Roads and Bridges within the Province, will be guided by a strict observance of the same in the returns made by them, of their respective accounts ; and that they may be forwarded to him, at his office, in St. John, as early as circumstances will admit, and not later than the 1st day of October next :

WHEREAS it appears to this House, that the Accounts rendered by Commissioners of Monies expended on the Bye-Roads and Bridges, are frequently not sufficiently particular and explicit ; but that this in general proceeds from ignorance of what is required, and not from wilful neglect or default : Thereupon Resolved, that it is the opinion of this House, that, "The Commissioners of Bye-Roads and Bridges, in making up their accounts of Monies expended, should state in such accounts,

1st—"Whether any, and what parts have been done by Contract ; and if so, the names of the contractors, the nature of the Contract, whether so much per Rod, or other distance ; or so much for the whole ; or in what other way ; how the contract has been performed, and what sums have actually been paid.

2d—"If done by days work, to state the names of the workmen ; the rate of wages per day, of each man ; whether found in provisions or not ; the number of days which each man has worked ; the amount paid each man ; the quality of work done ; and the mode in which the same has been performed.

3d—"The proper receipts should accompany the Accounts of all Monies paid by the Commissioner ; and if the same are signed with a mark, they must be witnessed by at least one respectable witness.

4th—"The Commissioners accounts should be attested to, before a Justice of the Peace ; and the oath to be in the following form or to that effect :

"We, A. B. & C. D. the Commissioners within named, do make oath that the foregoing account is correct and true, and that the several sums therein mentioned as paid, have actually been paid by us, as therein stated,
