And be it further enacted, That any person or persons presuming to sell or dispose of any Lands, Tenements, Ships, Vessels, Goods, Wares, or Merchandise, by Public Vendue, Auction, or Outcry, without being thereunto duly Licenced and Appointed, and without having given Bond as directed by this Act, shall for every offence forfeit and pay the sum of one hundred pounds: Provided always, that nothing herein contained shall extend or be construed to affect sales made under the process, order, or decree of any Court of Justice, or by any public officer or officers, or by any Executor or Administrator of the Lands or effects of the Testator or Intestate, or of any property, real or per- lying and being in the Parish of Kent, known by Lot No. sonal, belonging to the Crown. X. And be it further enacted, That every Vendue Master or Auctioneer, who may be Licenced or Appointed within any of the Counties of this Province, (the City of Saint John excepted,) shall pay to the Treasurer of the County, within ten days after the beginning of every Year, such tion issued out of the Supreme Court at the suit of Joseph Yearly sum as the Justices of the Peace of the County, at any General Sessions of the Peace, may direct and appoint, not exceeding Ten Pounds per annum, the same to be applied in like manner as other County Rates ; and every Vendue Master or Auctioneer, neglecting or refusing to pay the same, shall forfeit and pay the sum of Twenty Pounds, to. be sued for and recovered by the County Treasurer for the time being, in his own name by Action of Debt, in any Court of competent Jurisdiction, together with Costs of Suit; and the same, when recovered, to be applied as above mentioned, in which Action, any Inhabitant of the County shall be considered a competent Witness.
