WEDNESDAY, March 5. House opened at 12 o'clock, when the adjourn-

ed debate wis resumed.

Mr. M. I. Wilkins commenced the debate and delivered an eloqent speech which lasted over two hours, and was succeeded by Mr. McLellan, who spoke for about an hour and-a-half against the amendment.

The Hon. Prov. Sec. then addressed the house for more than an hour, after which Mr. Marshall rose and occupied another hour in favour of the amendment, when the Hon, J. W. Johnston closed the debate' for the evening in a speech which occupied nearly three hours. He reviewed every speech, and argument that had been advanced from the Government side of the House; "and closed his remarks with an explanation of his own objects and intentions as respects the future, so touching in its nature, that meet who listened to the honourable and venerable speaker, will for ever remember it for the instructive lesson it conveyed, and the saddening thoughts which it called up."

The Bill for authorising the draining of a Peat Bog, near Liverpool, with an amendment.
