# Provincial Parliament.

LEGISLATIVE COUNCIL. FRIDAY, February 18, 1859.

HORTON ACADEMY. Hon. Mr. Pineo presented a petition from the Executive Committee of the Baptist Education Society, praying a continuance of pecuniary aid to the Horton Academy. He also presented the Report of the Institution.

(It appears from this Report, that instruction is afforded at the Academy in the ordinary English Branches, Mathematics, Chemistry, Natural Philosophy with experiments, Physiology, Composition and Declamation, the Classics and French. The average attendance during the past year was 51. A complete set of philosophical apparatus, costing \$300 in Boston, was purchased for the exclusive use of the Academy, in 1858.)

CROWN LANDS.

Hon. Receiver General, by command of His Excellency, laid on the table of the House the Report of the Commissioner of Crown Lands

The number of grants issued during the past year was 511, containing 78,231 acres. The quantity being limited in most instances to 100 acres.

The gross receipts for Crown Lands during the past year amount to £6,265 19s. 2d.,-the amount repaid on rejected petitions, £1,317 0s. 9d, leaving a balance of £4,948 19s. 1d. to the credit of the Province. Nett proceeds for the year, £3,091 10s. 1d.

Mines and Minerals .- There have been during the past year 40 applications for Licences to search for Mines, and 10 for Licences to work Mines. Some of these Licences have been issued, and others are in progress.

Cape Breton.—The Commissioner complains very much of arrears of business connected with this Island. 151 petitions remain undisposed of, in consequence of no part of the considerationmoney for the grants applied for having been paid. The Commissioner states, that there are 3000 families on the Island who have no title to the lands upon which they are settled.

The Commissioner complains of the state of several Townships, in respect to their grants, particularly of that of Clements, in the County of Annapolis.

Owing to the form of several of the early grants the rights of the Crown to a large extent are involved in considerable embarrassment.

The number of acres reserved for the use of Indians is, in all, 26,027. Some of these lands are of a very superior quality, especially those in Cape Breton.

The Commissioner considers that the policy of retaining these lands in their present derelict state is very questionable, neither benefitting the public nor the Indians.

Ungranted Lands.—It seems that the area of the Province, including the Island of Cape Breton, is calculated to contain from 12,000,000 to 15,000,000 of acres, three-fourths of which are in Nova Scotia Proper, and one-fourth in Cape Breton. There remain ungranted in Nova Scotia Proper 4,086,497 acres and Cape Breton 1,210,960. Much of the ungranted lands in Cape Breton are of a good quality and very favorable for cultivation.

Of the ungranted land in Nova Scotia Proper, a large portion, especially as it approaches the southern shores is unfit for tillage and destitute of any valuable growth of timber.

Squatters .- The Commissioner observes that there are from 500,000 to 600,000 acres in the possession of squatters in Cape Breton, representing at the usual cost upon the smaller estimate the sum of £55,000. Some of these are no doubt entitled to grants under the Act of 1854. upon the production of their receipts or other evidence.

The Commissioner recommends that in these and all other similar cases the occupants should be notified to take out grants, or surrender their

> WEDNESDAY, Feb. 23. POST OFFICE.

Hon. Receiver General, by command of His Excellency, laid on the table of the House the Report of the Postmaster General of Nova Scotia,

for the year ending 30th September, 1858. The number of Post Offices has increased from 40 Post Offices and 103 Way Offices in 1857 to

71 Post Offices and 294 Way Offices in 1858, The number of newspapers carried in 1857, was 1,193,488,—in 1858, 1,211,016.

The expenditure of 1858 exceeded that of 1857 by £477 1s. 6d. The nett available receipts of 1858 amounted to £7,979 3s. 1d., showing an increase in 1858 of £553 17s. 7d.

The total number of routes now established throughout the Province amounts to 158, at an annual cost of £8,736 17s. 11d. The mails from the capital to Windsor and Truro are now conveyed by rail daily, the Railway Commissioners charging the Department £600 a year for the two services. The mails are conveyed by Messrs. King from Windsor to Annapolis for £5 a year. Mr. Cunard, Mr. Hyde's contract having been transferred to him, conveys the mails from Truro to Pictou daily for £300 per

The Postmaster General states that he considers the £5 from Windsor to Annapolis is a mere nominal amount, the contract in his opinion being taken by Messrs. King at that rate in order to entirely exclude competition. He thinks that when this service is again submitted to competition, it will, probably, cost not less than £300. He recommends the establishment of a daily mail between Amherst and Truro, the Postmaster General of New Brunswick having made arrangements for a daily mail from St. John to Amherst after the 1st June next.

operation on an early day. The sale of Postage stamps has increased from £2,855 5s. 2d. in 1857 to £3,175 13s. 5d. in 1858.

The Postmaster General strongly recommends the compulsory prepayment of letters by stamps, as facilitating the business of the Post Office, both as regards mailing and delivery of letters: and concludes his report by stating that the premises in Dalhousie College are not sufficiently large for the convenient despatch of the increased amount of business.

### NEW ELECTORAL BILL.

Hon. Attorney General asked leave to introduce a bill for the better Equalization of the Elective Franchise in certain counties. The hon. gentleman explained the details of the bill, and stated that its object was to remove the inequalities that at present existed in the representation of certain counties.

This bill proposes to put the counties of Colchester, King's, Hants and Pictou on an equality, to accomplish which one member will be taken from Hants and given to Pictou. These counties are to be divided into two electoral districts, returning two members each.

The county of Halifax is proposed to be divided into two electoral districts, returning five members-the eastern district returning two members, and the western (including the city)

Inverness will receive an additional member With the exception of Yarmouth, Shelburne and Queen's, which are not touched by the bill in consequence of there being no inequalities in these counties, there will in future be no distinction of county and township representation -members will be returned for the county

In Colchester, in the northern district, there are at present eight polling districts, and in the southern five. It is proposed by the bill to give the northern district seven, and the southern six districts. After some remarks the bill was read a first time.
