ARRIVAL OF THE ARABIA.

By the steamer "Arabia," just arrived, we are enabled to bring up our English news to the latest dates. The "Arabia" left Liverpool on the 30th June, and Queenstown on the 1st July; has been detained off the harbor by fog, since yesterday evening. She brought 124 passengers, 24 for Halifax.

THE COURT OF NAPLES ON ITS KNEES.

The Neapolitan Government and King are down on their knees. They court France; they ask for protection; they promise a more liberal form of Government than France will like to see in Southern Italy. Neapolitan agents are offering friendship to any journal which will advocate the cause of Francis II. The King, who yesterday murdered the Palermians, ere the blood is washed off his guilty hand, asks honest men to shake it. M. Brenier, the French Minister at Naples, has been mainly instrumental in working this change at the Court of Francis II. But he would not have experienced so much success had not events in Sicily and the continental dominions spoken louder than diplomacy. The seized vessels are to be restored as well as their crews. Nothing can be more amiable than the King and his advisers.

Francis II. has succeeded in obtaining the moral support of Russia and Spain. The Ministers Plenipotentiary at Turin of the Czar and the Spanish Queen have each been told to inform the Cavour Cabinet that they may be compelled to withdraw and break off diplomatic relations unless Sardinia puts a stop to the expeditions continually leaving the ports of the new Piedmontese kingdom for Sicily. Priestly influence has triumphed with the Queen of Spain, whilst Russia owes a debt of gratitude to the late father of the King of Naples for assisting Nicholas during the war.

SERIOUS ILLNESS OF THE KING.

It is said that the King of Naples is dangerously ill; and his life is despaired of. A rumour is in circulation that he is past recovery, and is dying from poison.

GARIBALDI'S FLEET.

A steamer of 800 tons and 300-horse power, has been sold to Garibaldi for 460,000*l*. It belongs to a French company, and is called the Provence, a screw. This is the fourth steamer bought by Garibaldi. The others are the Amsterdam, Helvetie, and Belzance, besides two tugs.

MISSION TO ASSASSINATE GARIBALDI.

A letter from Genoa, in the *Siecle*, has the following:—"Garibaldi does not appear destined to perish by the pignard, as was feared by some of his friends. We learn from Messina that the famous Bosco, who accepted the mission to assassinate him for 25,000*l*., had not had the courage to commit the crime, but has, on the contrary, had an audience of the General, to whom he made important revelations."

THE SAVOY QUESTION.

The *Journal of Genoa* announces, according to reliable information, that the Count de Persigny and Lord John Russell had agreed upon the convocation of a European Conference for the adjustment of the question of Savoy.

RECONCILIATION OF AUSTRIA AND PRUSSIA.

Austria is beginning to see the folly of keeping aloof from those Powers whose aid she may possibly require. Her little disagreement with which Prussia has subsided into an agreement which will be cemented by mutual interests. She consented to open negotiations for resuming her alliance with her former German friends, on condition that Prussia should guarantee to her the integrity of her Italian possessions.

DEATH OF JEROME BONAPARTE.

The elder stock of the Bonaparte family is now extinct. Prince Jerome, the youngest and last surviving brother of the Emperor Napoleon I., died on Sunday night at his seat of Valdegenis, near Paris. He had been for a considerable time in a state of health that created apprehensions in his family, but the immediate cause of death was a recent attack of apoplexy which set medical skill at defiance.

On Tuesday the mortal remains of Prince Jerome arrived at the Palais Royal, where they will lie in State in a *Chapelle Ardente* till the day of the funeral.

It is said that at the same time, and with great pomp, the body of Napoleon I., with that of his brother, Prince Jerome, will be conveyed to St. Denis. All France will be represented at this important ceremony by means of deputations. The heart of Napoleon I. will remain at the Invalides.

It is understood that the President, Mr. Buchanan, having in an autograph letter to the Queen, expressed his personal desire to receive the Prince at Washington, his royal Highness will pay him a visit in that city, and that his Royal Highness will also accept an invitation from the City of New York.

N. S. Baptist Home Missionary Society.

For the information of the public we are requested to state that at a late meeting of the Home Missionary Board, the Rev. I. J. Skinner informed the Board that during the four or five months in which he had been employed as Agent of the Society, he had learned that in several of the Churches the Union Society principle had been, to some extent, in operation, and that under the present circumstances of the Society, and with the hope that the pastors of the churches would press the claims of the Society upon their people and so avoid the expenditure connected with the Agency, he tendered his resignation of both the Agency and Secretaryship.
