

The ADDRESSES to the Prince of Wales from the various religious bodies in Canada were read before His Royal Highness, The Rev. Dr. Fyfe, and the Trustees of the Baptist Literary Institute were introduced at Woodstock and Dr. F. read a brief address in which they state.

"The Institution which we represent is designed to impart a higher academic education both to males and females, and also to educate young men for the ministry, in connection with the Baptist denomination."

To which His Royal Highness responded as follows:—

"GENTLEMEN:—I thank you sincerely for the address which you have presented to me.

"In the Queen's name I acknowledge the expressions of your loyalty to Her Crown and Person; and for myself, I am grateful to you for this Welcome given to me by your Society."

POSTAGE.—The regulation concerning the prepayment of postage recently advertized to take place in Nova Scotia, has met with remonstrance from New Brunswick and the United States, and we find a new advertisement inserted in the same two papers stating that the former instructions are annulled, and postage to Canada, New Brunswick, P. E. Island, and the United States, will be as hitherto, prepayment optional.

General Intelligence.

DOMESTIC.

CIVIC.—The elections to the City Council on Monday resulted in the choice of His Worship SAMUEL R. CALDWELL for Mayor, for the ensuing year, and the following gentlemen for Aldermen.

Mr. P. C. Hill, was elected yesterday for Ward 1 to fill the vacancy occasioned by the resignation of Dr. Cogswell and Mr. Walsh for Ward 3 in place of Alderman Thompson, resigned.

ENTERTAINMENT.—The Committee of the Athenaeum Reading Room gave their second entertainment on Monday evening 24th ult. The Rev. Mr. Munro, gave an address on Education as a necessary auxiliary to Temperance. A. James Esq., spoke of the present licence law as a means of prohibition. Showing that it was but little understood what benefits might be secured by a faithful execution of its provisions. He also described a well known character in almost every neighbourhood where liquor shops are allowed—"the village drunkard." The bouquets by which the room was decorated were sold at the close and realized 27s. 6s.

The Hero, Ariadne and Flying-fish have arrived at Halifax and will proceed hence to Portland for the purpose of conveying the Prince and suite thence to England.

A large Tea Meeting was held at Lower Granville on the 21st ult., 700 persons are said to have been present. The sum of £47 was realized for repairing the Baptist Meeting house.

WINDSOR.—We learn that the late Bazaar at Windsor on the 12th realized the handsome sum of £235 which with £27 10s. generously given by G. P. Payzant Esq., leaves a deficiency of only £40 or £50. necessary in order to pay off the debt on the Meeting House. The sum we are informed, will be made up immediately.

A fine little boy, about three years of age, son of Mr George S. Brown, of Yarmouth, was drowned on Saturday week in a pond only about thirty yards from the residence of the family.

INCENDIARISM.—About one o'clock this morning, some villain entered the Dwelling House of George L. Chipman, Esq. on the Bedford Basin Road, and having piled up some books, papers, &c., and several chairs, with some pieces of boards, (which he obtained from an adjoining room,) on a bed, set fire to it, going away and leaving the doors wide open after him. Fortunately the smoke awoke Mr. Chipman who was sleeping in an adjoining room. He succeeded in extinguishing the flames before much damage was done. The roads being soft the villain was traced some considerable distance, both to and from Mr. Chipman's premises. No doubt it was some person who was well acquainted with the House.—Recorder.

HALIFAX AND QUEBEC RAILWAY.—We learn by a letter received from London that Mr. Nelson, formerly Secretary of Lord Bury, is about to visit us for the purpose of procuring signatures to a petition for the Halifax and Quebec Railway. He is also about to establish a loan company similar to those in operation in Canada, for the purpose of advancing money on Provincial Securities—to be called the New Brunswick and Nova Scotia Loan Company.—St. John Courier.
