The losses in the battle of Fredericksburg seem to have been much greater than was at first apprehended. It is said that more than one hundred thousand soldiers are now in hospital or on the sick list in the Northern States. Slavery is inflicting a bitter retribution both on those who have practised it and those who have winked at it, in the late Union.

There has been some severe fighting near Mumfreesboro, in Tennessee, (we believe,) in which the Confederates are said at first to have prevailed, but were finally repulsed. Both parties, from the accounts received, must have suffered heavy loss. There has also been a sharp encounter near Kinston, in North Carolina, in which the Confederates are said to have been thoroughly beaten. No detailed accounts, however, of either of those actions have as yet been received.
