THE last session of the Legislature under our present constitution is now closed, and we may consider this, our country in a state of transition, to be succeeded by a combination under a new constitution, with new boundaries, and having a new name-CANADA. In a few days we shall doubtless have Her Majesty's Proclamation making us an iptegral portion of this great Confederation of the British American Provinces. We shall till be Nova Sectians, but we shall, for all purposes of commerce, finance, and international intercourse be Canadians. We lose nothing, but we gain much. Every elector will shortly be called to exercise his privilege in the choice of men to participate in the government of four millions of people, instead of three hundred thousand as heretofore; in addition to which they will have to send men to our local legislature to provide as formerly for our local necessities. By this change dignity is added to our position, and every citizen will perceive that he is placed in a far more responsible situation. Political morality is of higher value, and it becomes a duty for every individual to make himself acquainted with the matters on which he will be called to exercise his voice. There will of course be differences of opinion, respecting the various arrangements to be made, arising from conflicting interests and the difterent points of view taken by men, but these may now be all settled by an increase of the electoral privilege. Revolutions are generally accompanied by commotions more or less destructive, but this revolution bringing in a new era for British America has thus far been brought about by calm, quiet legislation, and affords a fresh triumph of the adaptation present necessities of our race. British liberty combined with British protection is a boon which we trust may be ever enjoyed by us, as well as by our fellow subjects, the world over.
