

The Railway Returns for last month shew an increase of \$166 44 over April, 1866.

The Rev. Mr. Temple returned from Bermuda on Wednesday by the *Delta*. His health, we are pleased to learn, is considerably improved.

**EXPLOSION AND ACCIDENT.**—The steam boiler in connection with the extensive leather tannery of Mr. John Logan, Pictou, exploded on Tuesday last, but fortunately no person was injured, as the explosion occurred while the men were at dinner. Five minutes previous the explosion, Mr. Logan fell and broke his shoulder-blade.

**PROGRESS.**—The New Mason & Hamlin Cabinet Organ with six stops, imported for the St. Andrew's Church, was used on Sunday evening last, and affords entire and perfect satisfaction. It is we believe the first organ that has been in use in a Presbyterian congregation in Nova Scotia.

**THE NEW POORS' ASYLUM.**—We understand that the contract for the new Poors' Asylum to be erected on the South Common in the rear of the City Hospital, was taken on Saturday last, by Mr. Henry Peters. The figures of those who put in for the contract stood thus:

Two years is the time specified for the fulfilment of the contract. The building which will be a first-class one, will be composed of brick and granite, and is to be of a very ornamental character.

**LIBERALITY.**—We have been requested to copy the following from the *Unionist* of Wednesday last:

It affords us much pleasure to be able, from time to time, to chronicle acts of liberality on the part of those who take up their residence, though it be but temporarily, among us. An instance of the kind, has just fallen under our notice, which reflects credit upon His Excellency the Vice Admiral upon the station, Sir J. Hope who is expected to leave our shores at an early day, indeed who is hourly expected to be relieved by Admiral Munday, who recently hoisted his flag on board the *Royal Alfred*. It is pretty well known, that the North Baptist Church of this city are about erecting a new, large, and handsome Chapel in Gorton Street, under the pastorate of the Rev. Mr. Goucher, their present place of worship has become too small to hold the congregation that assembles there. Often the House is crowded to overflowing, and sometimes at the hour of evening service numbers of people have to retire, not being able to procure admittance. A committee appointed for that purpose, have purchased the site for a new building, and the talents and taste of Messrs. Elliot and Busche have been called into requisition, who have furnished the designs and plans of a Chapel, which we have seen, and which, when completed will, we think, challenge competition and vie in architectural beauty with any thing of the kind in this city, or indeed in this province.

One of the parties entrusted with the subscription list informed us the other day, and not without some hesitation, he and his colleague decided to give His Excellency the Admiral among others a call. They were received very courteously. Having examined with much interest the plans and listened to their explanation, Sir James unhesitatingly responded to their invitation, and gave them a handsome donation "wishing them much success in the enterprise."

Our informant making us acquainted with the facts and particulars, will be as much surprised probably when he reads this relation of them, as His Excellency Admiral Hope himself, whose unostentatiousness in the matter and manner of his donation, at a time too, when he is about to retire from the station, do him much credit.—But without the leave of either, we do not hesitate to make such an act public, that others may do likewise.

This liberality is appreciated the more because with very few exceptions, the Baptists worshipping at the North-end, are among the poor of this world, and to enable them to complete their House of worship they will have largely to rely upon the liberality of other congregations and of persons of other denominations.

This building will be an ornament to that part of the city where it is about to be erected, and with the site will cost, it is estimated, about sixteen thousand dollars. Mr. William Harris has taken the contract, and the foundations are now in course of preparation.—*Com.*
