

confidence in, and affection for this worthy man by Mr. Crawley were highly satisfactory and gratifying, to those who had for several years been contributing the small pittance on which he had subsisted while devoting himself so successfully to the evangelization of his fellow-countrymen. (Ko Ang receives about \$100 a year from the Granville St., Missionary funds.) Several others of these laborers Mr. C., so graphically described that the audience might be regarded as almost seeing before them some of those devoted converts, men who with their intelligence and ability might be receiving four or five times as much salary in government offices.

We hope that Mr. Crawley may be induced to give another address, or lecture, or "talk" as he modestly termed it, on this highly interesting field of missionary labor. We understand that the Young Men's Christian Association have applied to him to do so at as early a day as convenient. Mr. Crawley has now gone on to Boston, for the purpose of meeting the Board of the Baptist Missionary Union, after which he proposes visiting his parents at Sydney, C. B.

We are glad to see that the robust constitution of our brother has not suffered by his fifteen years of labor in the jungles, towns, and villages of Burmah. Mr. C. is a noble specimen of manhood to give to this work, and is greatly beloved by our brethren of the Union, as well as by the Burmese missionaries and converts.

OVERBOARD.—A sailor fell into Miller's dock, South end, on Thursday night, and narrowly escaped drowning. He remained in the water some time, and when rescued was completely exhausted.

HALIFAX ASSOCIATION FOR IMPROVING THE CONDITION OF THE POOR.—A copy of the report for the past year has been sent us. Last year the Society received \$2458.53, but even this amount was too small to meet the exigencies of the work to be performed in relieving distress. THE HALIFAX JAIL.—From the Jailor's return for the year ending 1st December, it appears that there have been 200 debtors, and 245 criminals; in all 445 persons confined there. There are now in the Jail 9 persons, 6 debtors, and three criminals—women.

There is some talk, with a probability of the Lockman Street extension being accomplished.

Wm. Cunard, Esq., and family, left in the R. M. S. *Alpha*, on Friday last, for the Island of Santa Cruz, where they intend to spend the winter.

Forty workmen, Masons, Bricklayers, etc., left in the R. M. S. *Alpha* for Bermuda last week, to work upon the Government Buildings there.

Messrs. Ferris, O'Neill, and Tasse, Dominion Inspectors of Prisons, have been in Halifax during the past week overlooking the Provincial Penitentiary.

Snow fell in Halifax on Tuesday night of last week, after we had gone to press and stated that we had had none to remain. We had good sleighing all the week since.

On Wednesday afternoon a man named Brady, under the influence of liquor, jumped into Steel's pond, Freshwater, and narrowly escaped drowning.

GOLD IN KING'S COUNTY.—The Wolfville "Acadian" says there is quite an excitement in reference to gold diggings on the Gaspereaux Mountain, directly south of Wolfville. Several years ago Dr. Hea discovered gold at this place, but until recently no steps were taken to test its value. Mr. Nathan Harris and several American gentlemen have commenced operations, and it is said that others, including some Australian miners, are about doing so. The "Acadian" says Mr. Harris has been offered \$1,000 for his rights.

SWINDLER ARRESTED.—A man named Knowlan, who has resided at Berwick, King's County, induced a number of persons to place goods in his charge for conveyance to Halifax. He disposed of the goods in Windsor, returned secretly to Berwick, and was making arrangements to leave, when he was arrested and lodged in jail.

GOLD.—The returns of gold from the various diggings in Nova Scotia for the months of July, August and September, amount to 5047 ounces 16 dwts. In value about \$100,000.

We learn that the "Cape Breton News" which has been suspended for several weeks, will be revived by Mr. Ward, the former Proprietor.

THE PROVINCIAL MUSEUM.—We understand that the Provincial Museum is about being fitted up under the direction of Professor Honeyman who is the right man in the right place. The want of such a museum has long been felt and we are glad to know that it is in course of progression, for it will be a valuable addition to the attractions of our Metropolis and one that will commend itself to strangers. The Museum is to be located in the long room on the top story of the Provincial Building.—*Rep.*

SUPREME COURT.—The Michaelmas Term of the Supreme Court, for arguments, commenced on Tuesday morning the 1st inst. Present on the Bench—The Chief Justice, Justices Johnson, Dodd, Desbarres and Wilkins. We understand that there are sixty-nine cases for argument, and only four weeks to dispose of them.

OUR SCHOOLS.—There are 4,460 children now attending the public schools in this city. The number attending the public schools in the County of Halifax, outside of the city, is about five thousand. Every day's experience goes to prove that the Education Law is an excellent one, and will be of incalculable benefit to the rising generation. We trust the Legislature will keep a watchful eye upon any bill, which may be submitted during the next session of the House, having for its object the amendment of the existing School Act.—*Unionist.*

WINDSOR.—We learn that there is every probability of ship-building being brisk at Windsor next Summer. Messrs. B. Smith, S. Dimock and Wm. Fitch, and others, intend, it is said, to re-open their shipyards, and put under construction at least one ship, a barque, a schooner and a brigantine.—*Rep.*

STORM.—Halifax was visited with a severe storm on Monday night and Tuesday morning. The winds blew with great fierceness and rain fell in torrents. The shipping in the harbor sustained great damage. Several vessels lying at the wharves were sunk. We fear that we shall hear of great disaster all along the coast.

TRURO.—We are informed that the Baptist Church here is enjoying a season of much interest. Five persons were baptized on Lord's day last, who were subsequently with others received into fellowship.

PRESENT: HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL.

ON the recommendation of the Honorable the Minister of Customs, and under and in virtue of the authority given by the 10th section of the Act passed during the late Session of the Parliament of Canada, 31st Vic. Cap. 44, intitled: "An Act to amend the Act of the present Session, intitled: "An Act imposing duties of Customs with the tariff of duties payable under it." His Excellency in Council has been pleased to approve of the following additional Regulations respecting Drawbacks claimed on the exportation of goods under the said 10th section of the Act above referred to, viz:—

REGULATIONS.

1st. Goods having been entered for duty and having passed into the hands of the importer, in cases where the said goods are found not to be the goods ordered, notice of such fact may be given to the Collector of Customs at the Port of Entry, within one month of the date of such entry, accompanied by a request for leave to return the said goods to the place and party where and from whom the same were purchased, and that the duties paid thereon be refunded; whereupon the Collector having verified the statement of the importer, and having ascertained that the package to be exported is a whole package, and that its contents are identically the same as originally entered for duty, shall report the same to the Department, and the Minister of Customs shall thereupon issue an order to the Collector to refund the duties upon due proof of exportation; Provided that: if such goods are not actually exported within one month from the date of such order it shall be void and of no effect.
2nd. Whereas cases frequently arise for which no general order or regulation is provided, in which goods upon which duty has been paid require to be exported, and injury or hardship may be endured by importers, to the disadvantage of the general commercial interests of the Dominion, unless some means of redress be provided. It is therefore ordered that in all such special cases, it shall be lawful for the Minister of Customs to consider the grounds and examine the merits of each application, and make such order thereupon subject to the approval of the Treasury Board; as may, in his judgment, be necessary for the relief of the parties, and consistent with the interest and security of the revenue.

GOVERNMENT HOUSE, OTTAWA, } 23rd day of October, 1868.

PRESENT: HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL.

Whereas it is provided by Cap 5, of the Act 31st Vic., Sec 10, sub sec 5, that "the Governor in Council may make such regulations as may be considered advisable for the appointment of Suffrance Wharves and Warehouses at which goods arriving by vessels in transit to other Ports or confined to certain days of departure, may be landed and afterwards stored before entry;" and whereas it is expedient that the accommodation so contemplated should be afforded in all cases where the same may be found necessary,—His Excellency in Council, on the recommendation of the Honorable the Minister of Customs, and under the authority of the said recited Act has been pleased to order and it is hereby ordered, that on application to the Minister of Customs, by the owner or master of any Packet Steamer, or other vessel being a regular trader, specifying the name and tonnage of the said steamer or other vessel, the general time of her arrival and departure, and the ports between which she is accustomed to sail, also designating the wharf at which she is accustomed to land and the building in which it is proposed to store her cargo, it shall be lawful for the said Minister of Customs to declare the said wharf and building to be a suffrance wharf and warehouse or the purposes of the Act, and to authorize the Collector of the port to grant a warrant of license, for a specified time, to the master of such steamer or other vessel to land his cargo and store the same at the wharf and in the building so declared to be a suffrance wharf and warehouse, without previous entry, the said Master having previously executed a bond to the Crown in such penal sum as the said Minister of Customs may consider equitable, but not less than one thousand dollars, providing that the said Master will not fail to leave in the hands of the Landing Waiter or other Officer of Customs appointed for the purpose, a report of the Contents of his vessel for each voyage, and he will in all other respects conform to the requirements of the law in such case, and will use his utmost diligence to prevent any infringement thereof by any person or persons arriving at such port in his vessel.
