THE REPORT :-THE PROGRESS OF THE COMPANY during the past year has been of a very satisfactory character, and it is matter of congratulation that, during a

period of great distrust and dissatisfaction in the Assurance world, the business of this Company has increased, not decreased. THE NEW ASSURANCE TRANSACTIONS PROPOSED to the Company from 15th November 1868 to 25th

November 1869, the Company's financial year, amounted to the large sum of £1,460,867, 2s. 9d. contained in 2026 Proposals—of which 407, for assuring £350,520 were not considered eligible, and declined.

THE NEW POLICIES ISSUED during the year were 1619 in number, and the Assurances effected amounted to the large sum of £1,110,847, 2s 9d.; the new Annual Premiums being £38,532, 2s 8d.

THE CLAIMS BY DEATH amounted to £822,117, 11s. 8d., the number of deaths being 564; and the Bonus Additions to the Policies which became Claims amounted to the further sum of £36,649, 10s. 10d.

THE INCOME OF THE COMPANY received during the year ended 15th November 1869, amounted to £710. 428, 16s. 3d.

THE INVESTED FUNDS, as shown in the Balance Sheet, which follows, had reached the sum of £4,284,684, 7s. 3d.

THE NEW BUSINESS OFFERED to the company since the last Division of Profits in 1865-that, is, in four years—has amounted to £5,652,481, 12s. 7d, the number of Proposals being 8788.

THE SUBSISTING ASSURANCES at 15th November 1869 were £16,845,419, 2s. 6d., of which £931, 819. 12s. was reassured with other offices.



ANILINE DYES IN PACKETS.

THESE dyes were introduced into New Brunswick, a few months ago by J. Chaloner, St. John N. B., and being found to work well have been favorably received by the public. They are as follows:

Magenta or Roseine, Magdala Pink, Crimson, Scarlet, Purple, Blue, Violet, light and deep Yellow, Green, Brown, and Poncean Scarlet. Green requires pure wool in order to success, part cotton flannel wont take it. Most of them dissolve freely in hot water, others have to be first dissolved in a little spirits, and then added to the boiling water. Directions go with each packet. They are very easily used, all required is to dissolve the dye in boiling water, and put in the goods. Iron vessels should not be used, a milk dish well heated previous to the operation is the best. Some of these dyes make good Inks viz: Purple, Violet, Blue; Poncean makes fine Jeily or Syrup coloring, or Red Ink.
