Halifax is not now dependant on the United States as formerly for fall fruit. The W. & A. Railway brings from Annapolis and King's Counties some of the most choice and delicate varieties of apples.—Quantities of grapes too are sent from Kings County.

ANOTHER N. S. FOREIGN MISSIONARY.—The Board of Foreign Missions in connection with the Presbyterian Church of the Lower Provinces met in New Glasgow last week, and decided that Rev. Joseph Annand, designated Missionary to the South Seas, should sail from Halifax for his destination, via London and Melbourne on the 5th of November.

POLITICAL.—The Elections.—Returns from Yarmouth represents Mr. Ryerson elected by a majority of one over Mr. Flint. Mr. F. demanded "a count" and the Sheriff adjourned his court till Tuesday.

In Inverness Dr. Campbell was returned by a majority of 82. The votes were for Dr. Campbell 1384, for Mr. McDonald 1302.

In Pictou Mr. McKay's majority over Mr. Marshall was 723.

THE FRUIT EXHIBITION at Wolfville, last week was attended by a large concourse of people. The quantity of fruit on exhibition was not so large as on some previous occasions, but the quality was in many respects far superior to that of former years. The pears, were in advance of previous exhibitions. The grapes grown in the open air, were remarkably fine. There were, of course, monaster beets, turnips, pumpkins and squashes.

By Herbert Harris, Halifax, Awarded to John H. Shaw, Berwick.

The Hamilton Prize.—Dr. C. C. Hamilton offered a prize of \$2 for one dozen Gravensteins, the best formed and highest colored. It was awarded to the Dr. himself. He offered \$3 for a collection of ten sorts, one dozen of each sort, of the smallest, most indifferent looking, ill shaped, worse flavored apples, grown in any county in the Province, not being Crab Apples and not necessarily grown by the exhibitor. It was awarded to Irad Benjamin Gaspercaux.

The Starr Prize.—\$3 for the largest and heaviest dozen of apples, not necessarily of one sort, but grown by the exhibitor. By Richard Starr, Cornwallis. Awarded to E. E. Dickie, Canard.

The Association also offered a prize of \$10 for the best collection of apples, not to exceed twenty-five sorts, three of each sort each collection to be accompanied by an affidavit that it was grown by the exhibitor; and the apples to be named and labeled. Awarded to Andrew H. Johnson, Falmouth. \$7 for the second best, awarded to J. Christopher Starr, Cornwallis, \$5 for the third best, awarded to Avar Longley, Paradise.

The Peakes Prize.—\$10 given by J. D. Peakes of Halifax for the best eight dozen apples from Annapolis, was not competed for.

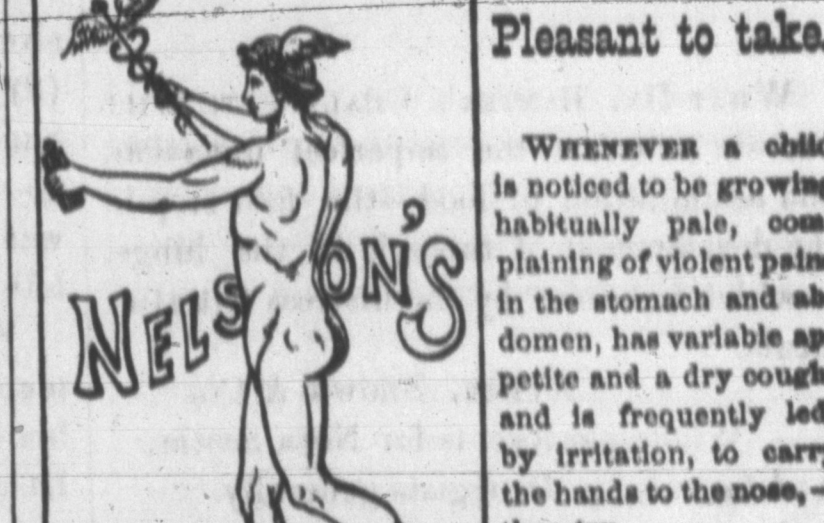

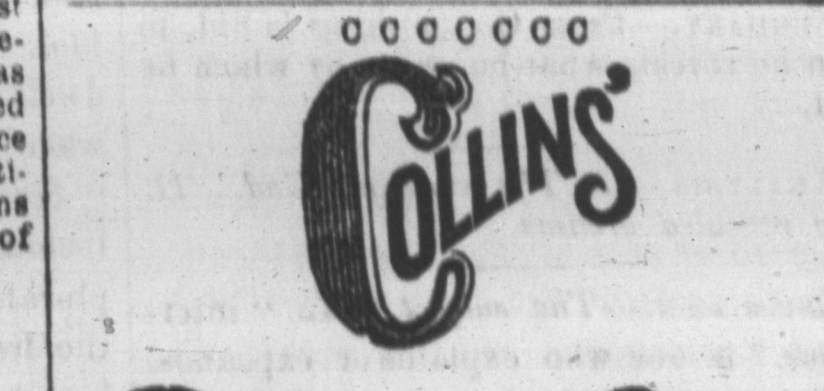
