

There will doubtless be some difference of opinion on the probabilities of this matter; and whatever may be the decision given next week, there must be no relaxing of effort in the Lord's work on the part of any of those concerned.

Whether the removal of the Board to Yarmouth will be the wisest arrangement may possibly be called in question by some. So far as the Yarmouth brethren are themselves concerned, there is no cause to feel any doubt. Their zeal in all that concerns the advancement of the work in that locality is a guarantee that their ability is fully equal to every demand which may be made upon them.

We shall not forestall the action of the Annual Meeting of the N. S. Home Missionary Society, by any further expression of opinion, but hope that there may be a free, full and earnest consideration of the question in all its bearings, and a wise decision given, all the parties thereto seeking the best interests of the cause, the glory of God, and the extension of the kingdom of our Lord Jesus Christ.

ECCLESIASTICISM IN HALIFAX.

Halifax has had an abundant supply of Divinity during the past week. The Presbyterian Synod and Wesleyan Methodist conference both sitting here at the same time has added about a quarter of a thousand to the ministerial corps of the city—about an equal number of each body.

The statistical information of the Presbyterian body is very distinct and full. In almost all their various Missionary and Benevolent funds there has been an increase.

The total of the whole funds in 1871 was \$19091.80, and in 1872, \$22773.52; being an increase of \$3681.82. From the report of the Committee on Statistics we learn that four returns were wanting, and a considerable number were very late in coming in. Much inconvenience was caused by delay and tardiness of Sessions. There are still 19 congregations that pay less than \$500 a year to their pastors. There are 7 that pay less than \$400. The contributions this year all over the church average \$9.24 per family—14 cents in advance of last year.

Rev. George Patterson was unanimously elected Moderator for the ensuing year. The whole attendance will be about 182—the largest ever held in the Maritime Provinces.

The Marriage Affinity question was warmly discussed on Friday and following days. There were some opposed to the Church interfering in the matter, but the large majority affirmed the view that church action should be taken in cases of marriage with a deceased wife's sister, or with a deceased husband's brother.

The Wesleyan Conference opened its eighteenth Session on Thursday last. The officers elected for the present year are Rev. James C. Hennigar, President; Rev. Dr. Stewart, Vice President; Rev. D. D. Currie, Secretary; and Rev. A. Alder Temple, Journal Secretary. Four candidates were recommended for ordination, and thirty for continuation on trial.

The Mission Funds, Contingent Fund, Supernumerary and Educational Funds were reported on Saturday. The Book-room and "Provincial, Wesleyan" were reported in a healthy and prosperous condition. Dr. Pickard was reappointed Editor and Book-steward.

Rev. R. C. Crane a much esteemed minister of the body died on Friday last.

The Rev. Mr. Punshon's Lecture on Friday on the "Men of the Mayflower," was a magnificent piece of platform oratory. The historical and biographical references to the King, and to the several leading men who came over in the Mayflower, and landed on

Plymouth rock, the principles of religious freedom enunciated, and the account of their demand for adherence to Bible teaching, was altogether one of the grandest combinations of historical facts and massive eloquence that we ever heard.

Rev. Mr. Sedgwick's motion for a vote of thanks to "this admirable Punshon," was not the least amusing part of the evening.

We visited the Camp meeting grounds at Berwick last week. They are in the midst of a forest of tall trees 50 or 60 feet in height, to which a road of a few rods in length has been cleared. The entrance and the whole place has a most romantic appearance, covered over as it is by the spreading branches of the tall spruces. The underwood is cleared away, and seats sufficient for about 2000 persons are placed on the ground, gradually rising from the two-story covered platform. We suppose it is intended to erect tents between the trees, all around the central seats, for the use of those who remain on the ground through the meetings. We hope, for the comfort of those in attendance, that the mosquitoes, will be smoked out as we hear they usually are on such occasions.

HOME MISSIONARY CONVENTION.

The following paragraph should have appeared at the close of our last week's report on this subject:—

The location of the Board being determined upon, one of the Yarmouth brethren nominated thirteen brethren living there to form the Board of Managers.

The Great Peace Jubilee Festival seems to take precedence all other matters in our United States exchanges and indeed in nearly all the papers on this side the Atlantic. "The Hub of Creation" as Bostonians designate their city, has certainly reason to be proud of the success which seems to have attended the musical performances in the great Coliseum. PUBLIC NOTICE is hereby given that parties entitled to re-bond and re-warehouse Tea and Coffee under the recent resolution of the House of Commons, notice of which appears in the Extra of the Canada Gazette of this date, may so re-bond and re-warehouse such Tea and Coffee at the nearest Port at which the same may be; or such Tea and Coffee may be deposited and re-warehouse in any Inland Revenue Warehouse, should such Inland Revenue Warehouse, be at or nearest to the place where such Tea or Coffee may be, the Collector or Officer of Inland Revenue having charge of such Warehouse, in a place where no Customs Warehouse exists, being instructed to receive such Tea and Coffee in the manner and under the conditions in the said notice mentioned.
