results than in any subsequent year of its history. During that year, Rev. S. N. Bentley was its general Agent.

Judge McCully has great faith in Statisties. So have we. To shew the progress of the Home Missionary Society, he invites us to examine the statistics of the last five years. It is a pity that he did not turn back the dial hand of time to 1859. the most prosperous year of the Society. To shew which way the progress has been, let us examine the statistics of that year as compared with those of 1872.

These figures speak for themselves. But according to its honorable Treaurer, the Home Missionary Society has been making progress. This may be progress, but it seems to us like Paddy's progress when he fell down hill -" rapid and casy, but all the wrong way."

The progress of the, so called, Home Missionary Society during the last five years, should not be placed to the credit of the Society, for Judge McCully says " practically there is no Society." The progress is due to a revival of Missionary interest in the Churches. And this progress during the past five years has been very far from being commensurate with the increase of population and the growth of the churches.

Now as the work done by the Home Missionary Society in 1872 was much less than the work done by that Society in 1859 and as the Union proposes to employ a general Agent, as the Society did, in the last named year, collect information from all sources about the wants of the field, and strive to meet them, it is reasonable to suppose that the Union would do more work than is being done by all the Societies at the present time. But we must now leave this part of our subject and recur to it again.

+---GROSS SUPERSTITION.

Not the least deplorable part of the great ecclesiastical conflict which is inflaming the public mind in all parts of Europe is the gross character of the superstition which is inculcated. Upon some Catholic deputies interrupting him, the speaker drew out of his pocket a strip of paper, the length sup-posed to be the height of Christ, covered with prayers in coloured print. "This," he said, " is the sort of thing sold with the permission of the priests as a safeguard against fever and typhus. It is only od .cheap and nasty." I leave you to imagine,

Dominion & Foreign News.

HALIFAX, N. S., APRIL 23, 1873.

Hon. Mr. Howe left Ottawa by the noon train on Friday last, for Boston, en route for Nova Scotia. He was attended to the station by nearly all the members of both Houses.

The Ottawa Times of Saturday morning said " it had long been the common rumor that, on the expiration of General Doyle's. term of office as Lieut.-Governor of Nova Scotia, Mr. Howe would be invited to act as his successor. We cannot conceive of any appointment that would be more pleasing to all shades of politicians in Nova Sectia. A son of their own soil; a patriot who has grown old in the service of his country; a man who has rendered distinguished service to the whole of British America, and to the Empire of which it forms a part; who has done everything that a man can do, except to enrich himself -such a man must as surely be acceptable to the reople of his own Province in the capacity of Her Majesty's Representative on certain state occasions, as it would be pleasing to the people of the whole Do-minon to see him in his old age occupying that exalted position.

Mr. J. G. Bourinot, formerly connected with the Halifax Reporter is appointed assistant clerk of the House of Commons.

Hon. Dr. Tupper's resolution providing a system of inspection of the quality and quantity of gas, passed after lengthy discussion.

The debate on Mr. McDonald's vote of censure on Mr. Anglin, M. P. for Gloucester, N. B., resulted on Wednesday last in a majority of 26 in favor of the motion It has been reported that Mr. Anglin would resign his seat in the House in consequence of this vote.

Ice in the St Lawrence River, opposite the city of Montreal has caused the river to rise rapidly. St. Paul's is deeply submerged. At many places in Point St. Charles the inhabitants are compelled to resort to boats and rafts. Farms along the Lachine road are flooded from 3 to 4 feet, and in some places 8 feet. Unless the rise subsides serious damage is apprehended.

The Dominion Line will run its steamers Lord Clive, Palestine, and Mississippi, between Boston and Liverpool, this summer, and will increase its service in the fall.

A woman in Toronto, named Armstrong, found her husband and servant girl in her bed room on Saturday last, and having armed herself with a pistol shot at the guilty pair. The ball grazed the husband's cheek but lodged in the girl's eye. The wife gave herself up to the police.

Emigration from Europe to Canada bids fair to assume larger proportions during the coming season than ever before. It is said that Ireland will contribute thousands, and there are large numbers already on the way from England, Wales and Scotland. But that is not all, Germany, Russia, and Belgium it is said will also contribute large numbers.

On Monday the House of Commons in Committee on the Bill empowered the Grand Trunk Railway Company to issue more bonds. Wrong may have been done, but it cannot be helped, and corrected only by working for peace in love, and thus disappointing the great enemy. Bear and forbear, be bent on the things that make for peace, and thus some of the greater evils of removals will not be. - W. of R.
