ANTIGONISH .- The labours of Rev. J. B McQuillan in this section of our Province have received many tokens of the Master's approval. It is only a few months since he reported to us the ingathering of a large number, nearly one hundred souls, into the fold of Christ, in the St. Mary's dis tricts of Goshen and Glenelg. We now learn that the town of Antigonish has been visited by a gracious revival-the little church is greatly encouraged and sinners are being aroused to their need of salvation. We understand that this work of grace is to some extent a result indirectly of the labours of the Rev. A B. Earle in Halifax. One of the brethren was visiting Halifax at the time the Evangelist came among us and was impressed with the Spirit's which evidently accompanied the preaching of the Gospel, and being anxious that others might be benefitted by the gracious visitation, telegraphed for his eon and nephew, two young lads, to come to the city, hoping that they might share in the blessing. Although our brother did not see immediate results in the conversion of those so dear to him, still he had reason to know that their consciences were awakened and he returned home encouraged to pray and wait. The Lord of the harvest did not long delay the answer to his petitions. in the prayer-meeting about two weeks ago the quickening Spirit was manifestly present, and those two young lads were the first to rejoice in "the new song." The ingathering has been largely from the Sabbath School but its influence is extending and deepening. From a letter which we have seen from there we extract the following :- " It may be said now that the church, sabbath-school, and congregation are a converted people, but few are left out. Wednesday of last week was our greatest night-no less than twelve found Christ at the meeting, and four others told how they had found him since the evening before. We count eighteen who have given evidence of conversion, and many more are anxious." May the Lord continue to comfort Zion until the desert shall rejoice and blossom as the rose."

NEW BRUNSWICK .- At a meeting of the New Brunswick Home Mission Board last week several missionaries' reports were read with the account of their labour in different parts of that Province. Rev. T. Todd's report of labor comprises " preached 60 times, attended 13 social meeting, 6 communion services, baptized two, prayed not less than two hundred and thirty times with private families. Travelled in all about 1,500 miles. Collected for Home Missions \$185.21. Secured the interest on \$68 for many years to come for Home Missions. Collected \$14.40 for Foreign Missions. Found where a will was made bequeathing \$200 to the Foreign Mission Fund. Attended one ordination; found many churches without pastors, and some pastors without churches. Recuscitated the Union Society in forty-two churches. Wrote 42 letters of advice, &c., to ministers and churches. The fields are white all ready for the harvest.

In reference to the application of some brethren at College, to spend the four weeks of their winter vacation, it was resolved, that it was inexpedient to send them out for so short a period at this season of the year.

On motion, Rev. G. W. Springer was sent out on a three months mission, as an evangelist, to labor with destitute and declining churches, and assist pastors in revival work, at the rate of \$600 per annum."

A serious riot was reported from Vicksburg, Tuesday the Sth, us a result of the dispute concerning colored Sheriff Crossby. The city was attacked by armed negroes, who were repulsed with a lose of 40 killed and wounded, while there is only one white person reported killed. Governor Ames is charged with having incited the negroes to

A later report stated that the negroes lost 70 killed. Reinforcements were flocking to each side and an assault was expected

A telegram on Wednesday said, reports from Vicksburg, Miss., stated the excitement had largely subsided. Crossby, the Sheriff, has resigned, and the city is under martial law.

Subsequent accounts show that a larger number of negroes were killed and wounded than was at first reported.

Governor Ames issued a proclamation ordering the rioters to disperse. Disturbances are now believed to be all

over and quiet. The supervisors have ordered an election to fill the vacancies of sheriff. circuit court elerk, two justices, and two constables.

Two men were killed and four dangerous. ly wounded on Thursday by the explosion of a boiler near Vicksburg.

A collision of railroad trains near Boca, Nevada, caused the death of two persons, and probably the fatal injury of two others. Several persons are reported missing.

A smart shock of an carthquake was experionced in New York on Thursday night, causing much consternation.

A fire at Charlestown, West Virginia, destroyed \$200,000 worth of property. The Grand Trunk Railway has made a

SOUTH AMERICA.

The commander of the British man-ofwar "Cracker" telegraphs from Montevideo, 9th inst., contirming the report that an insurrection had broken out in Urugua. Government troops refused to march against Insurgents, and demanded the resignation of ministers.

MEXICO.

The Mexican Congress is debating a bill restricting the powers of the Roman Catholie Church, one clause of which provides for compelling a separation of the Church and State. Amendments to the Mexican constitution making changes in Congress, and establishing a Senate, baving passed Congress, were solemnly promulgated as the law of the land.

LATEST FROM EUROPE.

ENGLAND - The London " Times" says that England, in reply to Russia's invitation, declares her willingness to attend the St. Petshurg Conference, though she regrets being unable to anticipate any prac-

The operatives in the Dundee jute mille, numbering 30,000 have struck in consequence of a reduction of wages on Saturday. The proprietors renounced their intention of reducing the wager.

The Rev. Mr. Maconochie a well known Lindon Ritualiatic elergyman has been suspended for six weeks from the exercise of his clerical functions. The London Times considers the politi-

cal position in which President Grant is the message to Congress, it says that no intervention in Cuban matters by Great Britain is possible. A gale prevailed on the British coast on

Wednesday last. A large vessel, supposed to be the John Cook, from Quebec for Shields, was totally wrecked Fifteen of the crew drowned. Nine vessels ashore at Hartlepool. Several wrecked at Seaham. There was much damage to houses and other property on shore.

A dezen vessels went ashore at Whitby, and one was reported sunk with all on board. Similar accounts have been received from points all around the coast. The mails from France were several hours behind time. The storm was also very severe on the Continent.

It is feared that the steamer Pelican, from Cardiff for Cork, is lost with all on board. Passengers and crew numbered 49. Disrael is at Bournemouth. He says

that his absence from London will be protracted.
