The following is from an English Baptist paper. Some of our Pedobaptist brethren in these provinces may by it be disposed to try and discover some case of infant baptism in the early christian church. Dr. Stock brings it forward as another argument for believers' baptism. He says:

None of the distinguished fathers of the early Church were baptized in infancy. This is the more remarkable because most of them had devout Christian parents, and yet we have the record of their baptism after conversion. Clearly, then, in those families infant baptism must have been unknown. Some of these fathers were the children of Christian ministers, and yet remained unbaptized, until they were upwards of twenty years of age. Athan usius, Basil, Gregory, Nazianzen, Carysostom, and Nestorias, in the East; and Ambrose, Jerome, and Augustine, in the West-all but the first, born after the begining, and several of them after the middle. of even the fourth century, and most of them known to have had Christian parents, -not one of these was baptized in infancy. though several of them were devoutly dedicated to God from their hirth. We are not aware that there exists any evidence that will prove that one single known father of either the Eastern or Western Church was raptized in infancy during the first five hundred years after Christ. Will those of our Pædobaptist brethren who are more learned in patristic lore than ourselves supply us with a case of the kind if they can produce one? The Fathers whose names we have mentioned are all known to have been baptized when grown up, and after a professed conversion to God. But are there any others whose names have escaped our notice that can be proved to have been haptized in infancy? If so, let
