

HALIFAX TO NEW ZEALAND.—The brig-antic Ocelot which sailed from Nova Scotia arrived at Auckland, on the 6th of April, after a voyage of 110 days.

DOMINION & FOREIGN NEWS.

DOMINION OF CANADA.—The water is slowly subsiding in the over-flowed districts. In the Rideau Canal it had subsided four inches on Saturday.

An Order in Council has been issued appropriating about 96 miles of old iron rails from the Intercolonial.

Hon. P. C. Hill, Provincial Secretary of Nova Scotia arrived at Ottawa on Friday last.

A most atrocious murder was perpetrated in the township of Madoc on Sunday, on the body of Mary Ann Lynch, wife of James McQuillan.

The ship Dunbartonshire arrived at Quebec on Sunday, the 14th, she was 24 days in the ice in the Gulf, and had one plate stove in; 13 other vessels got clear when she did.

A dreadful catastrophe occurred at Rondeau school-house, on Monday 14th Inst. A violent flash of lightning exploded about the building.

The Elementary Education Bill was introduced in the Commons on Wednesday.

Mr. Disraeli was sick and could not attend the banquet at Guildhall.

Lord Derby still refuses to surrender Winslow to the United States.

The ex-King of Hanover and suite arrived in London on Tuesday.

The schooner Thomas Street capsized on Wednesday at Lake Erie. Six of the crew, mostly Canadians, were drowned.

George Esson, Jr., has been appointed Inspector of Inland Revenue for Nova Scotia, vice Archibald Patterson.

Dom Pedro the Emperor of Brazil will shortly visit Montreal and Toronto.

A telegram appeared in the Montreal Witness stating that several of the Oka Indians had been attacked and fired at by French Canadians under the leadership of a man named Fautex.

Six grocery firms in Ottawa went into insolvency on Monday last.

On Monday at Montreal the floods rose again in consequence of the heavy rains. A carding mill was carried away at Chau-diere.

New Brunswick.—At St. John the stalls in the new market building were sold on Thursday for \$6,400, and the total revenues, exclusive of rents for eighty shops, will be \$11,000.

At a meeting in Fredericton last week a resolution in favor of the Miramichi Railway Valley route was carried; only one person being favorable to the central line.

In the trial of Thomas O'Neil for the murder of his mother-in-law, Bridget Fothergill, the defence of emotional insanity was set up.

The Penitentiary for the Maritime Provinces will be built at Dorchester. The plans are in course of preparation.

The Albert Mining Company have lately struck a new seam of Albertite said to be 13 feet wide.

P. E. ISLAND.—John Burns died at Pleasant Valley, on the 4th inst., aged 102 years.

UNITED STATES.—Several parties are trying to nominate a person for the Presidency but as yet have been unsuccessful.

A Brownsville, Tex., despatch of Tuesday last says Gen. Escobedo is within sixty miles of Matamoros with 2500 men.

A serious fight occurred at Laurel Hill, Louisiana, between negroes and whites on Friday night.

The British Mediterranean fleet have been ordered to Salonica.

The Porto has refused to allow Greek men-of-war to pass the Dardanelles, declaring that the Powers which signed the treaty of Paris are alone entitled to station vessels of war in the Golden Horn.

The dedication of the new English church is indefinitely postponed at the request of Elliott, the British Ambassador, who consulted the Minister of Police on the possible consequence of the ceremony.

A panic prevails among the Christians in Ruzschuk, and the foreign consuls have sent their families for safety across the Danube.

The Mussulman inhabitants of Pridor, in Bosnia, under the pretext that a number of Christians were about to quit the town, attacked and massacred 100 persons.

The deaths from the plague at Bagdad from the 23rd to 29th were 306, and at Hillah 148.

National Bank, known as the Provincial Bank of Buenos Ayres on Thursday last suspended specie payments and numerous failures including that of a private bank occurred.

ENGLAND.—The reception and entertainment of the Prince of Wales in London on Friday night was a magnificent affair.

The Princess and members of the Royal Family, arrived at the Guildhall soon after seven o'clock, after the triumphal progress, the streets being crowded with spectators.
