

Austria has recalled all her officers in the Turkish service.

ITALY.—In the Chamber of Deputies at Rome on Friday last, Minister Nielgoir said the agitation in favor of restoration of temporal power of the Pope deserved no serious consideration.

On Monday of last week the Pope received several delegations of pilgrims. His general health is improved.

Fifteen hundred French pilgrims were received on Friday at the Vatican. The Pope entered the Ducal Hall where the pilgrims gathered, accompanied by 12 cardinals and many distinguished prelates.

Local News.

SMALL POX.—We had a notice last week of the appearance of small pox in the County of Shelburne. We have since received a further notice of the victims in the family of Mr. Smith Harlow.

On Tuesday, the 27th of March, Mary O. Harlow was taken sick; Dr. Burns was sent for, and on Sunday sent for again, and came again on Sunday, the 1st day of April, supposing it to be small pox. He left them and returned on Tuesday night, during which time the family had all taken it. On April 19th Deacon James P. Harlow died, and on the 21st Theodore Harlow, and on 24th Perez F. Harlow died, all brothers, leaving Mary O. Harlow and Zilpha Harlow, Alexander Harlow, all sick, but recovering.

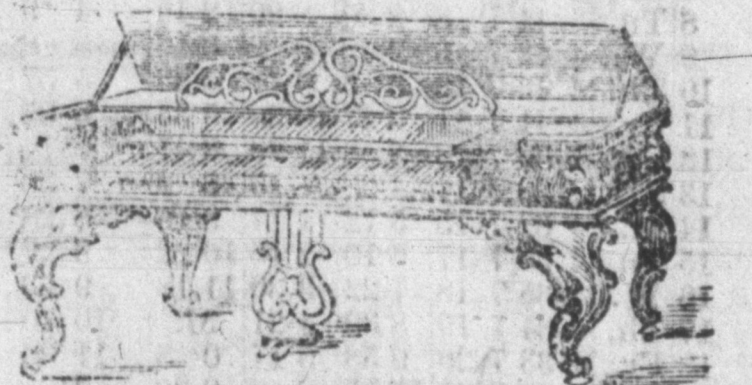
