A SAD CASE OF MURDER AND SUICIDE occurred on Thursday last in the village of Dovor on the shore near the entrance of Halifax harbor:

One version of the affair is that Chas. Cleaveland had a dispute with one of his sons about some land, out of which much ill-feeling grew, resulting in a law suit, which was to have been tried at the approaching term of the Supreme Court. On Thursday Cleaveland was in his house talking about this dispute in a very excited manner; at last he took down his gun and, loading it, expressed his determination to kill the son who was the disputant. His wife attempted to detain him, fearing the consequences should he leave the house in such a temper with the loaded gun in his possession. He instantly threw her from him and, turning the muzzle of the gun towards her, fired. She fell to the floor, apparently fatally wounded. Her father who was the only person present beside Cleaveland, attempted to seize him, but was quickly overpowed. Cleaveland loaded his gun again and deliberately fired a. second shot at his wife. This last shot killed her outright. He then began loading the gun for a third time, when the old gentleman fearing that he was to be the next victim of the infuriated man, made his escape from the house and ran to alarm his neighbors. Several of them collected, but, knowing that Cleaveland | Treasurer, feeling that the town has last had a loaded gun, they did not care to enter the house. In a short time however, a third report was heard, and entering the house the neighbors found the wretched murderer lying on the floor dead, beside the unfortunate victim of his insane fury. The sight was a sad ble position, but we can but add our one indeed. Cleaveland had a family of eight children, five sons and three daughters, all of whom were married. He always bore a good character and from this place will be much regretted was on very good terms with his wife by the people generall, whose respect and all his family, except the son with and confidence he had won. Another version of this dreadful case is that the man was continually quarrelling with his wife, and had on the previous day deliberately planned to shoot her.
