**Local News.**

**PROVINCIAL APPOINTMENT.**—Provincial Secretary's Office, Halifax, Nov. 1878. His Honor the Lieut. Governor, by the advice of his Executive Council, has been pleased to make the following appointments:

To be Members of the Legislative Council of the Province of Nova Scotia, —Hiram Black, of Amherst, in the County of Cumberland, Esquire; James Simon Macdonald, of the City and County of Halifax, Esquire.

On Saturday night there was a severe south east storm of wind, snow and rain. There was a considerable amount of activity amongst the vessels lying at the wharves of the city, many of them sustained slight injuries, but none any serious damage.

The lakes were frozen on Saturday but the ice was not safe. Several lads who were skating broke through and got a wetting, but no further casualties occurred.

A fire broke out on Tuesday last in the upper part of the building occupied by C. H. Whitman & Co. The store had been closed about an hour before. It is supposed that the fire originated from a defect in the flue of the house adjoining. It was extinguished after working some time by the firemen, but the building and goods were much damaged.

On Wednesday afternoon last about 1/2 past 5 o'clock the government steamer Glendon was slowly coming up the harbor, when just off the market wharf a "dingy" boat containing seven men from the cable steamer Minia, lying in the stream, was coming on shore. The dingy attempted to cross the Glendon's bow, the boat was not observed until the steamer was close to her. The steamer's engine was immediately stopped and the men in the boat were shouted to, but they kept on rowing. The boat was still in the way and was run down. The boat filled, but was not much injured, as the steamer was hardly moving when she struck it. One man from the boat got over the bow of the steamer, three more were hauled on board with lines, and the other three were rescued by a boat which was launched from the steamer. They were only a few minutes in the water. There was a light in the Minia's boat, but it was not shown until she was under the Glendon's bows, when the steamer stopped, but too late. The men in the boat had a narrow escape.

On Wednesday afternoon a man named James O'Brien, while sitting at the dinner table in his boarding house on Gerrish Street, suddenly leaned back in his chair, making a sound as if choking, and died immediately.

At Barrington on Tuesday last Wm. Morricey shot himself in his own barn. It is supposed that the death of his wife a few months since, had so affected his mind as to lead to this sad end. He was a fisherman, fifty-three years of age.

A man named Gallagher, from Londonderry mines dropped dead at Green's Crossing on Wednesday last. He was subject to fits.

Lawrencetown, Annapolis Co. was the scene of a terrible accident, or worse, on Sunday the 15th inst. It appears that two young men, named Charles Taylor and Hiram Late, together with a girl named Amelia Freeman, called at the house of Mr. William Late, and persuaded his daughter, Emma Late, a girl of about 19 years of age, to go out for a walk with them. They walked some distance, and stayed out so late that they were unable to get into their homes. They then decided to go to Morton's mills and stay there for the night. On arriving at the mills, the two girls gathered some chips and wood, and made a fire in the fireplace. They all laid down by this fire, and it is said, went to sleep. About four o'clock, a. m., one of the men was heard knocking at his mother's house, and when she appeared at the window, told that Emma L. was badly burned at the mills. Some of the people were aroused, including Dr. Morse, who proceeded to the mill, and were met with a sight which almost baffles description. Her body was horribly burned. She was, however, still alive, but lingering in the most intense agony. She was taken to her home on a board, where she lingered in the most excruciating agony until 1.30 p. m., when death released her from her terrible sufferings. Taylor, Late, and the girl Freeman, were arrested and taken to Annapolis jail. On being questioned, they did not know anything about it, more than that when they were awakened Emma Late was all in a blaze.

At the meeting of the School Commissioners last week there were 76 applications for the office of Janitor for the new High School. Mrs. Donahoe was appointed.

The High School is to be publicly opened on the 6th of January.

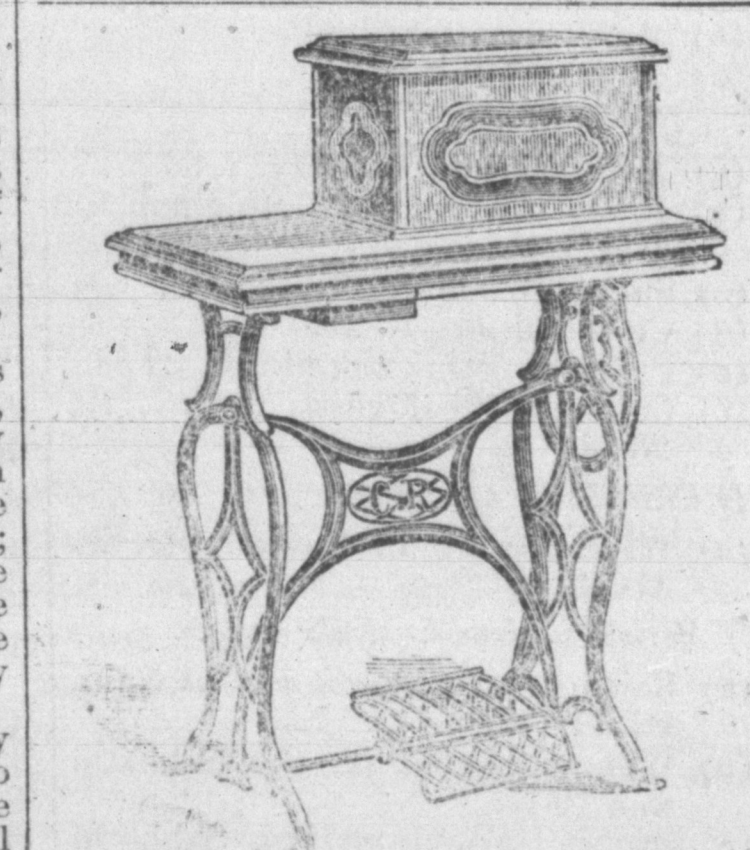
