REV. FATHER KEARNS delivered a lecture in St. Mary's Cathedral, on Sunday the 5th inst., on " the Divine Constitution of the Church," to which the public were especially invited. The lecture was afterwards published in one of our morning papers. Some of the things advanced were unquestionably true and very well put. But when the lecturer passed from the infallibility of the church to the infallibility of the Pope he had a far more difficult task, and was not equally successful We need not say that the evidence adduced to shew the supremacy of Peter, was without any reliable foundation.

THE REV. MR. PADFIELD of the Church of England in a subsequent issue of the same paper assumes the task of replying to Father Kearns. This he does by affirming that the Roman Catholic Church has failed to establish its claim to the successorship to the Apostles; He argues that-

" The Papacy is an intermittent office, becoming continually vacant, and then filled and conferred by a merely human election. One Pope cannot be said 'to hand over his gifts to his successor, because that successor is not appointed. until after his death, sometimes a long time afterwards."

The Manager's Report shewed them a very efficient body of gentlemen for their work.


The Superintendent's Report gave a very full and thorough review of the interior operations of the Institution.

"In the case of the Episcopacy this is very different, one Bishop receives his orders from other Bishops, and so the diminution. To give an illustration : Hibbert, Bishop of Nova Scotia, was consecrated in the year 1851, by John Bird, Archbishop of Canterbury, and three other Bishops, and we can trace on the line of succession to St. Augustine Bishop of Canterbury, and through him to Apostolic times. This is not a matter of opinion or faith even, but of historical fact, of which the records are extant."

This line of argument may please those of our Episcopalian friends who indulge in such tollies. It might help us to believe that they are the genuine successors of the Apostles, if there were were any such persons. But we find nothing in the Scripture, or anywhere else to warrant us in adopting such a Popish notion. It is a very sad thing if this is their only claim to the succession,

Having the characteristics of the Apostles, and doing the same work as they did, we regard as the only things that prove the succession. However directly they may have descended, if if they have no other claim, it will be of as little worth to them as it was to those in the church at Ephesus who said they were apostles, and it was found they were not. 
