To accomplish equalization it was not necessary that the academy grants should be raised to \$1,400, or because it could not be assumed that the large grants were to be continued to the counties of Pictou and Yarmouth. And Whereas, it is desirable to utilize the powers above referred to with a view to the consolidation of the several railways under one management, in order to secure their more efficient and economical working, and in order to restore to the Prevince as large a proportion as can be obtained of the moneys advanced for the construction of the said railways by the sale of the interests

referred to. Be it therefore resolved, that the Government be authorized and empowered to enter into negotiations with any person or persons or corporations, for the purpose of effecting a sale of the interests possessed by the Province in said railways or any of them, and to contract for such sale upon the best terms that can be obtained therefor, having regard to the ability of the contractors to carry out their negotiations, and to furnish satisfactory security therefor, and to contract for the completion of such roads and any of them, and for the construction and working of a railway in the Island of Cape Breton, to connect with the Eastern Extension Railway and ferry at the Strait of Canso. Any contract to be made under this resolution to be subject to the approval of the House.

## DOMINION & FOREIGN NEWS.

DOMINION OF CANADA.—It is understood that his Excellency the Governor General and suite will leave for Quebec the first week in May, remaining there about a month. On the arrival of her Royal Highness the Princess Louise and party, a couple of weeks salmon fishing will be enjoyed on the St Lawrence, after which the Vice Regal party will proceed to Halifax to be present at the general military review to be held there on Dominion Day. About the middle of July they will start on their North-West trip, which is expected to last a couple of months

The new cattle order from England prohibiting vessels which have carried cattle from any port in the United States to load cattle in Canada for a period of thirty days thereafter, has upset the arrangements of some cattle shippers. A train of cattle belonging to Mr N. Kennedy, which was about starting from Montreal for Halifax, was countermanded, and the cattle will now be shipped via Portland.

STRANGE FATALITY. - Advices from British Columbia state that the Chinese employed on the Canadian Pacific Railway works are dying rapidly from a mysterious disease, which seizes them in the feet, whence swelling proceeds rapidly upwards towards the vitals, killing them in fifteen minutes. Over a hundred have died and the disease continues.

On Sunday last at Pointe Claire, the old and new Catholic Churches and Pilon's Hotel were completely destroyed and a man fatally injured by the falling of a ladder. He died about six hours afterwards. Loss is estimated at \$50,000
