Recent disclosures had increased the suspicion that the Land League was connected with outrages. He charged Parnell with heading an organization which had started agitation that promoted outrages and incited to murder. Parnell, he said, had reaped advantages from the agitation. He did not plan outrages, but connived at their commission. O'Kelly shouted " It's a lie " several

He was named for suspension, and

his suspension was ordered by a vote of 305 to 20.

A feeling is now rising even in Ireland against the agitation-Parnell and his friends had been unveiled and unmasked.

There were loud cries for Parnell, but he did not move. O'Donnell, on attempting to interpose during the speech. was ruled out of order.

In the evening Parnell made a lengthy speech in which he sought to make his position clear to the Irish people at home and abroad. He declined to answer Forster's questions. Gorst's amendment was rejected, the Parnelites abstaining from voting.

The developments by Carey in the trial of the prisoners for the murder of Lord Cavendish and Mr. Burke, during the past week, have fully indentified the guilty parties. It seems Carey was the Treasurer of the Fenian Brotherhood, and a leader of the Irish Invincibles, who had sworn to "remove" "all tyrants." The court room was a scene of the most intense excitement during these developments. He so far identified the murderers that he said he was in Phoenix Park with those who purposed to murder Mr. Burke and detailed how he saw seven men meet the two gentlemen. He said Curley, Joseph Hanlan and Fagan were the first, Brady and Kelly were next, and McCaffrey and Patrick Delaney came after. Lord Frederick Cavendish and Mr. Burke were allowed to pass through by the first three, and the last four then faced right about. When Carey again looked the two rear men had closed in on the two gentlemen.

The witness continued: I saw Joseph Brady raising his left hand and striking a man dressed in a gray suit. That was all I saw. (Here there was a sensation in the court room and loud cries of "Hush.") I timed my own movements accurately during the day. What I related occurred at 7.17 p, m After I left the Park I met at the Island Bridge Joe Smith, a person who was acquainted with Mr. Burke's appearance and had accompanied me for the purpose of pointing him out. It was Smith who told Kavanagh to hurry up and take the nosebag off. The witness repeated the conversation he had after the murder with Brady, who stated that he had stabbed Mr. Burke and afterwards settled Lord Frederick Cavendish After that he went back to Mr. Burke and put a knife in his

The witness detailed his conversation with Brady, who said he stabbed Mr. Burke in the left shoulder. The other gentleman came up and called him a rutlian. He ran after him into the road and settled him. He then looked round and saw Kelly coming away from Burke's body, and he and Brady went and cut Burke's throat. Brady said : "Lord Frederick Cavendish, when he spoke, struck me with an umbrella. I then made at him. He held up his arm and I struck it. He ran into the road."

It had been arranged that Mr. Forster was to be shot together with the other occupants of his carriage, and any one interlering was to be disabled. Here the prisoners laughed. On the night Mr. Forster left Ireland fifteen Invincibles actually followed him to thek Westland Row station Curley loo ed into the cars, but only saw Mr. Forsters's wife and daughter. The fifteen Invincibles were under the command of Curley on this occasion, who was obeying the orders of the mysterious Number One. As Mr. Forster had definitely left Ireland they were told to concentrate their attention upon not afford to have another. Mr. Burke.
