Ritson will confer with the Auxiliaries regarding withe work in the Dominion, and it is hoped the work may be pushed further afield, more especially in the Northwest Territory.

## SCIENTIFIC MEN AND RELIGION.

As regards the attitude of scientific men towards the Christian religion, the following striking fact is worthy of note: Dr. Wennart, of Berlin, has views of three hundred of the most distinguished men of science, living or dead. He finds that of the 300, 242 confessed themselves believers in God. Of the remaining fifty-eight, thirtyeight gave no information, or none could be obtained. There was left twenty, of whom fifteen avowed that they were unbelievers or agnostics, and five—only five out of 300!-professed to be anti-Christian Materialists. A further reduction may be made. For of those who seemed opposed to religion, especially on the Continent, some are not rejectors of real Christianity; it is Roman superstition that disgusts and repells them.

## NOVA SCOTIA F. B. CONFERENCE

The Yearly Meeting held at Kemptville, Yar mouth Co., N. S., August 24-29. At the Elders' Conference held on

Wednesday afternoon, the routine business was followed by a paper by Rev. J.E.Gosline on the Inspiration of the Bible. As this will be published it will suffice to say just now that it was an exceedingly thoughtful and clear discussion of the various theories held on that subject. It was evident in the debate that followed that members of the Conference were in agreement with Elder Gosline and each other, and the subject had occupied their attention both in and out of school.

The welcome meeting in the evening was large and lively, and set the pitch for the good fellowship which reigned throughout the session.

The business began at 10 a. m., on Thursday, the Moderator, Rev. G. M. Wilson, presiding. After appropriate opening exercises, the roll of members present was called, and the following visitors were invited to sit with the Conference: Rev. A. W. Currie, delegate N. B. F. B. Conference; Rev. A. J Prosser, of N B. F. B. Conference; Rey. Z. M. Miller, delegate Maine F. B. Association; Rev. G. E. Manter, of Maine F. B. Association; Rev. A. E. Lenyon, delegate Massachusetts F. B. Association; Rev. Wm. Hoppaugh, of Springfield, N. J. (Presbyterian).

The following report was presented by the Conference Executive:

At a meeting held at the time of the Quarterly meeting at Tusket, Rev. J. K. West was appointed auditor in place of Elder Weston, deceased, and Rev. G. M. Wilson was appointed treasurer of the Ministerial Aid Society.

During the year, in union with the special committee and the H. M. Board, Elders Cooper and Knollin have given pastoral care to the Beaver River pastorate, and Elders Knollin and Manter have given similar service to the Argyle and Kemptville pastorates. Over thirteen months' labor has thus been supplied.

We have appointed the following standing committees:

The Ministerial Aid Society's report showed receipts \$14.48, appropriations \$50.00, on hand \$97.70.
