The Pork-Packing Factory.

A Free Site Offered—Stock List Opened.

The meeting last Tuesday evening which was called by the town for the purpose of promoting a pork-packing establishment in Hartland was not as largely attended by the farmers of the surrounding country, as it should have been, considering the vast importance the project will be to them, should it be established. However, those who did attend took much interest.

The meeting was opened with A. F. Campbell in the chair. After several discussions it was decided to open a stock list and the same is left at R. W. Richardson's store for subscription.

A free site for the factory has already been offered by a gentleman who is much interested in the business.

Another meeting is to be held next Tuesday night at 8 o'clock in the hose house, and a large attendance is requested.

Sad Death.

A very sad death occurred early Saturday morning at the residence of D. H. Keswick when Robert Harold the 7-months-old child of Mr. and Mrs. Harris Keswick died. The little one had been ill for several weeks of cholera infantum, but had begun to recover. On Friday Mr. and Mrs. Keswick with the child came down to Hartland from their home in St. Leonards, and shortly after arriving the baby took worse. The funeral, which was largely attended took place at the residence of Mr. D. H. Keswick, and was attended by Rev. J. A. Seller. The bereaved parents have the heartfelt sympathy of the whole village.

Lawsuit.

A lawsuit took place before Squire McGee at Somerville on Wednesday. The case was between George Cowan of Rosedale, and a man by the name of Passmore. It seems that Passmore stayed at Cowan's last winter, and according to Passmore, he was to receive the sum of \$10 for services rendered. Cowan claims that the agreement was that Passmore was to work for his board. A jury was impaneled and brought for a verdict of \$3 for the plaintiff.

Change of Postmaster.

Charles L. Smith, M. P. P., for Carleton county received official notification Tuesday morning of his appointment as postmaster at Woodstock. He resigned his position in the legislature several weeks ago. Mr. Smith takes the place of Col. Vince, whose position was given him shortly before the change of government.

Shots Fired by a Woman.

A Case Before the Police Magistrate at Woodstock.

A serious case was opened before the police magistrate at Woodstock Monday afternoon. G. Herbert Long of the parish of Wilmot charges Mrs. Williams of the same place with having fired a pistol shot at him and his friend William Good on the 8th inst. It appears that the defendant complained that a bad feeling existed between the two families. At any rate she fired a shot from a revolver at the complainant and two more at the dog which accompanied him and his friend Good while they were at work. The prisoner was remanded until Thursday.

Fire at Newburg Junction.

A fire occurred at Newburgh Junction on Monday by which the buildings belonging to Joseph Robinson were consumed. They consisted of a fine dwelling house with ell, woodshed, and two barns, the latter filled with hay. Nearly all the household furniture was destroyed. All of the stock escaped except a dog. The fire took place about five o'clock in the afternoon and is supposed to have been caused by a defective flue. The loss is estimated at about \$2500; insurance \$950. Mr. Robinson had his buildings burned once before, 12 years ago, hence these were just newly built within the last few years.

Maritime Baptists.

The annual convention of the Maritime Baptists took place at Fredericton this week. Hon. H. R. Emmerson was elected president, H. C. Creed, Secretary, J. W. Spurden, treasurer.
