A Brazilian Sensation.

NEW YORK, Nov. 11.—A despatch to the Herald from Rie Janeiro says: Senator Viera, one of the government supporters in the Brazilian senate, declared in an open session that the opposition had predicted the death of President Moraes before Nov. 9. This statement taken in connection with the alleged plot which led to the recent attempt to kill the President, caused a sensation. Senator Barcelos, of the opposition, protested vigorously against the charge. In the chamber of deputies Seabara, in an at tack on the opposition declared that the party was made up of anarchists. This caused a hot discussion in that body. The many charges made have caused the opposition to publish a manifesto denying any responsibility for the attempt on President Morae's life. This manifesto, which sets forth that the attempt grew out of discontent in the army, was not well received. Comparative quiet reigns in Rio Janeiro, though the chamber of deputies has passed a measure declaring the city under martial law. Armed patrol surrounds the city.
