Beloved believe not every spirit but

try the spirits, whether they are of God: First Epistle of John 4 part 1. The Apostle here is speaking more especially to Christian Professors, many of whom are liable to be led astray, because of the many evil influences in the world. There are many false prophets and teachers whose doctrince is of Anti-Christ or the devil. Then we are to try the spirits, that is the spirit of God and the spirit of the devil. No man has ever seen a spirit. It is like the wind upon the trees-we see the branches swaying, the dust flying, the ships driven by the force of its power, and we feel its cooling effect. So mankind is propelled or drawn by the spirit of God, or the Spirit of the devil, as both have to do with us, although the world is full of God. Satan is as mighty and as crafty to deceive now as he was in the olden times, working upon the hearts and minds of the people, whether professors or unprofessors. Then we are to try the spirits, whether they are of God or the devil; not by our feelings or our consciences, but by the inspired word--the only true test. Jesus came down into our world to save the lost, and after His baptism the devil attacked Him in the wilderness and tried to buy Him over to his government, but could not move the Son of God.
