J. T. A. Dibblee, M. P. P.

J. T. A. Dibblee, junior member of the firm of W. F. Dibblee & Son, hardware merchants, was born in the town of Woodstock thirty-eight years ago, and this town and the county of Carleton has been his field of action. In his younger days there were no free schools, and he received his education at the schools conducted by Charles Gordon Glass and James McCoy. He sat at the



town council board four years, two as councillor and during the years 1890 and 1891 as mayor. He was elected to the house of assembly in 1892 with H. A. Connell, and since Mr. Connell's resignation he has been the sole surviving representative from Carleton County. He has already built the Hartland bridge, in miniature, as a glance at his store window will show, and it is to be hoped he will be able to carry out on a large and useful scale the idea of the model. Mr. Dibblee is a prominent member of the F. & A. M. and he is a Past Master of the Woodstock Lodge. The firm of W. F. Dibblee & Son does a large business in English, Canadian and American iron and steel goods of the finest quality. Their store is situated on Main street, and is one of the most attractive in appearance in the town. They do an immense business, wholesale and retail.

Grenville James,

UNITED STATES CONSUL.

He cut here shown is a very true likeness of Grenville James, the United States consul. Mr. James, who succeeded Walter T. Townshend a year and a half ago, was born in the city of Binghamton, N. Y., on the third day of August, 1869. The succeeding year his family removed to New York city, where they have resided ever since. In 1885



he entered the journalistic field as a reporter on the N. Y. Sun. From that time to the end of 1891 he was connected with the N. Y. World, Sun and the Daily Continent (since deceased) and was a free lance writer for several publications. In 1892 he was offered the United States consulship at Yarmouth, Nova Scotia, and took the oath of office on the 11th of May of that year. A year and a half later the change of administration resulted in Mr. James being succeeded at Yarmouth, and eventually receiving a commission from Mr. Cleveland as consul at Woodstock, which office he now holds.

Dr. Colter, M. P.

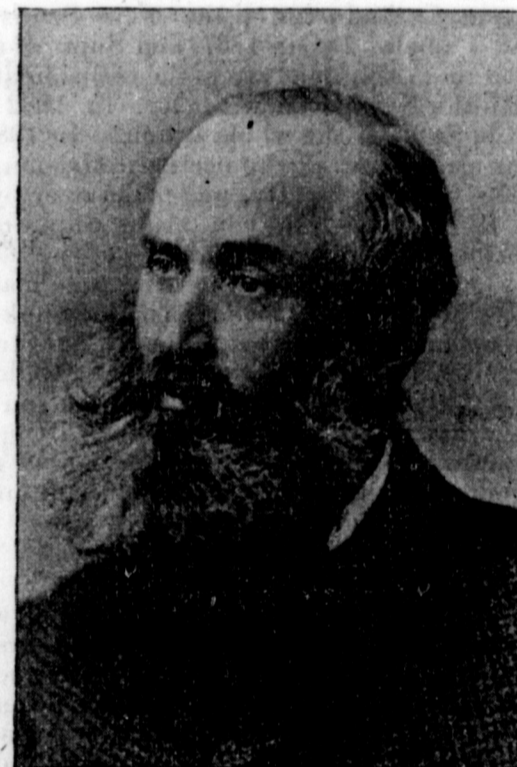
The photo below is a good one of the present member for Carleton county in the dominion house of commons. Dr. Colter was born in 1845, at Sheffield, Sunbury, Co., and is the fourth son of Alex Colter, a native of Leitrim, Ireland, who came to Canada and settled in Sheffield in 1826. He was educated at Sackville Academy, and graduated an M. D. at Harvard University, in 1866. From



Harvard he went to London, Eng., where he studied two years, and in 1868 came away with the degree of L.R.C.P. He married, in 1871, Jane, daughter of Geo. Hatt, of Fredericton. Dr. Colter is chairman of the Board of Health of Woodstock. He has been practising medicine here since 1868. He was first elected to parliament at the general election in 1891, and subsequently in the by-election 1892. It is hardly necessary to say he is a Liberal, and in favor of the fullest measure of reciprocity with the United States, it is possible to obtain, consistent with the honor and dignity of Canada. Since his presence in parliament Dr. Colter has worked actively for the deepening of the St. John river between Fredericton and Woodstock, and his efforts have met with considerable success. He has also been active in urging on the government the necessity of placing a fishway in the Meduxnakik stream at Woodstock.

J. C. Winslow.

John C. Winslow was born in Fredericton on the 24th of May 1826, and is the second son of the late J. F. W. Winslow, Esq. for many years sheriff of the county of Carleton. Mr. Winslow studied law at Fredericton in the office of the late D. S. Kerr. He came to Woodstock and formed a



partnership in law with the late Edwin Jacob. Afterwards he was in partnership with the late James Edgar, and still later with W. B. Chandler. In 1872 Mr. Winslow was appointed postmaster and he still holds that office. He is also registrar of probates having succeeded the late D. L. Dibblee. In earlier days Mr. Winslow took an active part in social affairs. He was a lieutenant in the Artillery corps of which Mr. James Edgar was captain. He was also at one time prominent in Masonic circles. He had a somewhat brief experience as a newspaper man, at one time being proprietor of the Acadian paper of which Mr. Edgar was the editor, and which was strongly opposed to Confederation. Mr. Winslow married in 1859, Charlotte L. O'Donnell, a daughter of Samuel O'Donnell, of Anherst, N. S. deputy crown land surveyor, of the county of Cumberland N. S.
